

DETAILS OF PACKAGE OF CONCESSIONS TO CENTRAL GOVERNMENT EMPLOYEES WORKING IN KASHMIR VALLEY IN ATTACHED/SUBORDINATE OFFICES OR PSUS FALLING UNDER THE CONTROL OF CENTRAL GOVERNMENT.

[Kashmir Valley comprises of ten districts namely, Anantnag, Baramulla, Budgam, Kupwara, Pulwama, Srinagar, Kulgam, Shopian, Ganderbal and Bandipora]

I. <u>ADDITIONAL H.R.A. AND OTHER CONCESSIONS</u>:

(A) Employees posted to Kashmir Valley:

- (i) These employees have an option to move their families to a selected place of their choice in India at Government expense. T.A. for the families allowed as admissible in permanent transfer inclusive of transportation of personal effects, lump-sum payment for packing etc.
- (ii) Departmental arrangements for stay, security and transportation to the place of work for employees.
- (iii) HRA as for Class 'Y' city applicable for employees exercising option at (i). Such employees will be eligible for drawing the normal HRA as well at their place of posting provided Departmental arrangement is not made for his/her stay.
- (iv) The period of temporary duty extended to six months. For period of temporary duty daily allowance at full rate is admissible, apart from departmental arrangements for stay, security and transportation.
- (B) Employees posted to Kashmir Valley who do not wish to move their families to a selected place of residence:

A per diem allowance of Rs.50/- is paid for each day of attendance to compensate for any additional expense in transportation to and from office etc.

Casual labourers with temporary status — Clarification regarding contribution of GPF and Pension under the Old Pension Scheme

The undersigned is directed to refer to this Department's OM of even number, dated the 26th February, 2016 (Sl. No. 87 of SwamysnewS. April, 2016) on the above subject and to say that some references have been received in this Department from various Ministries / Departments seeking a clarification with regard to the Para. 7 of the referred OM.

- 2. The OM was issued in consultation with Department of Expenditure and the Department of Pension and PW. It was clarified vide that OM that this Department's O.M., dated the 26th April, 2004 (Sl. No. 108 of Swamy's Annual, 2004) had been quashed in a series of Orders / Judgments. The OM, dated the 26th February, 2016 restores the provisions of the Scheme as it existed prior to the OM, dated the 26th April, 2004. The benefit of GPF and Old Pension Scheme is applicable to all those casual labourers who are covered under the Scheme of the 10th September, 1993 even if they have been regularized on or after 1-1-2004.
- 3. As the benefit of Old Pension Scheme and GPF is admissible only to those casual workers who are covered under the Scheme of 1993, all Ministries / Departments may strictly ensure that it does not lead to demand by regularly recruited fresh employees appointed on or after 1-1-2004 for similar benefit in place of NPS.
- 4. This issues with the concurrence of Department of Expenditure vide their I.D. No. 1(15)/E-V/2015, dated 27-7-2016.


Grant of Productivity Linked Bonus (PLB) and non-Productivity Linked Bonus (Ad-hoc bonus) in case of Central Government employees for the accounting year 2014-15- enhancement of the calculation ceiling-Regarding.

The undersigned is directed to invite attention to this Ministry's OM No. 7/24/2007/E-III.A dated 16.10.2015 regarding grant of non-Productivity Linked Bonus (Ad-hoc Bonus) to the Central Government employees for the accounting year 2014-2015, whereby the calculation ceiling for the purpose of payment of ad-hoc bonus was monthly emoluments of Rs. 3500. The Productivity Linked Bonus (PLB) in case of Central Government employees working under certain Ministries/Departments, where such PLB was in 2014-15, was also paid by the Ministries/Departments for the accounting year 2014-15 based on the concurrence of this Ministry with the calculation ceiling at monthly emoluments of Rs. 3500.

- 2. The question of enhancement of the calculation ceiling for the purpose of payment of PLB and non-PLB (ad-hoc bonus), as the case may be, to the Central Government employees has been considered and the President is pleased to decide that the calculation ceiling of monthly emoluments for the purpose of payment of PLB and ad-hoc bonus, as the case may be, shall be revised to Rs. 7000 w.e.f. 01.04.2014, i.e., for the accounting year 2014-15.
- 3. Accordingly, the PLB or ad-hoc bonus, as the case may be, as already paid to the eligible Central Government employees for the accounting year 2014-15 in terms of the above OM dated 16.10.2015 pertaining to ad-hoc bonus and the respective sanctions issued by the concerned Ministries/Departments in respect of PLB under the respective schemes in operation during 2014-15 based on the specific concurrence of this Ministry, shall be re-worked out based on the calculation ceiling of monthly emoluments of Rs. 7000 instead of Rs. 3500.

- 2. केन्द्र सरकार के कर्मचारियों को उत्पादकता संबद्ध बोनस और उत्पादकता असंबद्ध बोनस (तदर्थ बोनस), जो भी लागू हो, के भुगतान के प्रयोजन से उच्चतम गणना सीमा बढ़ाए जाने के मामले पर विचार किया गया है और राष्ट्रपति द्वारा यह निर्णय लिया गया है कि उत्पादकता संबद्ध बोनस और तदर्थ बोनस, जो भी लागू हो, के भुगतान के प्रयोजन से मासिक परिलब्धियों की उच्चतम गणना सीमा 01.04.2014 से अर्थात् लेखा वर्ष 2014-15 के लिए संशोधित करके 7000/- रुपए होगी।
- 3. तदनुसार, उत्पादकता संबद्ध बोनस अथवा तदर्थ बोनस, जो भी लागू हो, जिसका भुगतान तदर्थ बोनस के संबंध में दिनांक 16.10.2015 के उपर्युक्त का. जा. के अनुसार और इस मंत्रालय की विशिष्ट सहमित के आधार पर वर्ष 2014-15 में प्रचलित संबंधित स्कीमों के तहत उत्पादकता संबद्ध बोनस के संबंध में संबंधित मंत्रालयों/विभागों द्वारा जारी की गई संबंधित स्वीकृतियों के अनुसार लेखा वर्ष 2014-15 के लिए केन्द्र सरकार के पात्र कर्मचारियों को पहले ही किया जा चुका है, की गणना 3500/- रुपए के बजाए 7000/- रुपए मासिक परिलब्धियों की उच्चतम गणना सीमा के आधार पर पूनः की जाएगी।
- 4. लेखा वर्ष 2014-15 के लिए इन आदेशों के तहत उत्पादकता संबद्ध बोनस अथवा तदर्थ बोनस, जो भी लागू हो, के भुगतान की पुनःगणना करते समय, अन्य सभी शर्तें जिनके तहत भुगतान किया गया था, अपरिवर्तित रहेंगीं।
