

2. The transfer of services of the aforementioned officer will be purely on loan basis in CWC and shall be governed by the following terms and conditions :
- a) Employees of the Brahmaputra Board on transfer on loan basis to CWC may be treated as a regular employee of their parent organization, i.e., the Brahmaputra Board for all service matters. These employees will not have the option for "absorption" in CWC;



- b) Pay and allowances of these transferees will be regulated as per the norms of their parent organization, i.e., the Brahmaputra Board;
- c) For all practical purposes, the "Temporary Headquarter" of all these transferees will be the place of their actual posting in the CWC in terms of Supplementary Rules 59 (SR-59);
- d) There will not be any change in the Disciplinary Authority of these transferees. However, administrative control will remain with the Reporting Officers, where they will be posted and APAR/ACR of the transferees will be written/reviewed by the borrowing organization;
- e) They shall not be deemed to be regular members of the staff borne on the establishment of the CWC;
- f) The transfer on loan basis will be initially for one year or until further orders. The period may be extended on year to year basis depending upon the exigency of work in the CWC, based on a request received from the borrowing organizations on case to case basis;
- g) The salary, allowances etc. of all the employees mentioned in this order will be paid by the Brahmaputra Board.
