

- 2. The earnest money will be returned back to all the bidders except the first and second highest bidders after opening the quotations.
- 3. Rate should be quoted both in figures as well as in words.
- 4. The vehicle will be sold on 'AS IS WHERE IS' basis.
- 5. The Bidder should not be employee of CWC and should not have any relative working in CWC.
- 6. The Sealed quotations should be superscribed with 'Quotation for disposal of old LMV Maruti Gypsy AS-11/3130' due on 27/07/2019. The Quotations which are not sealed and without EMD will be liable for rejection.
- 7. The offer of the rate quoted should be valid for minimum 30 days from the date of opening of quotations.
