

Minutes of the 2nd meeting of the Tender Evaluation Committee held on 30th October, 2019 at 12:00 hours at Jalpaiguri for evaluation of Financial Bids for the work against NIT No. 07/2019-20/LBD/CWC/JPG dated 17/10/2019 to be undertaken by Lower Brahmaputra Division, CWC, Jalpaiguri.

A meeting of the Tender Evaluation Committee constituted by the Executive Engineer, LBD, CWC, Jalpaiguri vide letter no. LBD/DB-19/2018-19/4031-37 dated 27.12.2018 was held at Lower Brahmaputra Division, CWC, Jalpaiguri at 11:30 hours on 30th October, 2019 under the Chairmanship of Executive Engineer, LBD, CWC, Jalpaiguri.

The Committee discussed the following item :

Evaluation of technical bids for the work "Hiring of Support Services at Mekhliganj R/B site under JLT Sub-Division, CWC, Jalpaiguri in connection with hydro-meteorological observation and other ancillary works their upon during nonmonsoon 2019-20 under Lower Brahmaputra Division, CWC, Jalpaiguri"

Notice Inviting Tender for the work of "Hiring of Support Services at Mekhliganj R/B site under JLT Sub-Division, CWC, Jalpaiguri in connection with hydro-meteorological observation and other ancillary works their upon during nonmonsoon 2019-20 under Lower Brahmaputra Division, CWC, Jalpaiguri" against NIT No. 07/2019-20/LBD/CWC/JPG dated 17.10.2019 was floated on 17.10.2019 with estimated cost put to tender Rs. 4,13,810/= (Rupees four lakh thirteen thousand eight hundred ten) only. The approved tender document along-with Bill of Quantity (BOQ) were uploaded in the Central Public Procurement Portal (CPPP) website <http://eprocure.gov.in> & Central Water Commission website <http://cwc.gov.in>. The scheduled date & time of opening of bid was on 28th October, 2019 at 14:00 hrs.

As recommended by the committee during its 1st meeting held at Jalpaiguri on 29.10.2019 the financial bid in respect of the following one bidder was opened on 30.10.2019 at LBD, CWC, Jalpaiguri, details of which is as under :

It was observed by the committee that the total amount quoted by M/s Sathi Security, Saktigarh Road No. 8, PWD More, Behind NCC Office, P.O. - Siliguri Bazar, Siliguri - 734005 as **Rs. 719.87 (Rupees seven hundred nineteen and paise eighty seven) only** to be the lowest (copy enclosed as Annexure -I). The committee opined that the quoted lowest rate was abnormally low and unreasonable for executing the mandated work.

In view of the above, the Committee deliberated upon the matter and recommended for cancellation of the tender. The Executive Engineer, LBD, CWC, Jalpaiguri may go ahead for retendering process at the earliest.
