The envelope should be super scribed as EMD for Tata Sumo No DL3CQ1758. This EMD will be returned to all the bidders except the highest and second higher eligible bidder after opening the quotations.
- 2. Rate should be quoted both in figures as well as in words.

- 5. The undersigned will not entertain any claim for damage done by way of theft, fire or any other unforeseen calamity after realizing full payment against the sale of auctioned vehicle.
- 6. The auctioned vehicle is to be picked up within 10 days on the issue of letter of offer on making full payment thereof. Otherwise the earnest money deposited will stand forfeited and the offer shall be awarded to the next higher bidder.
- 7. The successful bidder has to tow/haul the vehicle at his own cost.
- 8. The successful bidder will return the dashboard/plate bearing Vehicle Identification Number (VIN) or Chassis/Engine No. at the time of delivery of the vehicle.
