This is in reference to the above cited letter received in this Directorate on 01/10/2019 on the above mentioned subject. Information on Point (4) and Point (12) out of the 16 Points pertains to WM Directorate and is detailed below:

# Reply to Point No. 4 & 12:

Central Water Commission is monitoring live storage status of 120 reservoirs of the country on weekly basis and is issuing weekly bulletin on every Thursday. Out of these reservoirs, 44 reservoirs have hydropower benefit with installed capacity of more than 60 MW. The total live storage capacity of these 120 reservoirs is 172.06 BCM which is about 66.74% of the live storage capacity of 257.812 BCM which is estimated to have been created in the country. As per reservoir storage bulletin dated 03.10.2019, live storage available in these reservoirs is 151.086 BCM, which is 88% of total live storage capacity of these reservoirs. However, last year the live storage available in these reservoirs for the corresponding period available in 113 reservoirs as per 03.10.2019 Bulletin is 117% of the live storage of corresponding period of last year and 123% of storage of average of last ten years.

Weekly Bulletin is also uploaded on the website of cwc.gov.in > water info>Reservoir Level & Storage Bulletin. This weekly bulletin is also shared with Crop Weather Watch Group (CWWG) of the Ministry of Agriculture and Farmers Welfare. Representatives of CWC also attend meetings conveyed by CWWG on every Friday to review agricultural activities across the country and to suggest remedial measures to states in case of distress situation. CWC regularly provides storage status of reservoirs and their analysis to the CWWG which is used as an important input.

Whenever the percentage of departure of current storage of a State goes below - 20% of Normal (Average Storage of last Ten years), Advisory is being issued to the State Govt. for judicious use of available water. Based on reservoir storage, CWC has issued advisory to the State Govts. namely Gujarat, Maharashtra, Uttar Pradesh, Andhra Pradesh, Telangana and Tamil Nadu in the month of May 2019, to Jharkhand, Karnataka and Kerala in the month of June 2019 and to Tripura & Uttrakhand in the month of July 2019 for judicious use of available water.

During 2015-16, Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) was launched by Union Government with an aim to enhance physical access of water on farm and expand cultivable area under assured irrigation, improve on farm water use efficiency, introduce sustainable water conservation practices etc. Under the PMKSY-AIBP, 99 priority projects have been identified out of ongoing 149 major

/ medium irrigation projects under AIBP with a dedicated funding mechanism to complete them in a time bound manner with the aim to be completed by Dec., 2019.

Drought Prone areas are given priority under AIBP/PMKSY. Total 54 projects benefitting drought prone areas in 11 States are part of the 99 prioritized PMKSY-AIBP projects. Government of India provides central assistance with higher funding ratio to irrigation projects situated in drought prone areas. For General category States, central share is 25% whereas for DPAP areas central share is 60%.

Ministry of Jal Shakti (erstwhile Ministry of Water Resources, RD&GR), Government of India is implementing the Scheme "RRR of water bodies" which has multiple objectives like Comprehensive improvement and restoration of water bodies thereby increasing tank storage capacity, Ground Water Recharge, Increased availability of drinking water, Improvement in agriculture/horticulture productivity, Improvement of catchment areas of tank commands, Environmental benefits through improved water use efficiency; by promotion of conjunctive use of surface and ground water, Community participation etc. The water bodies under the minor irrigation schemes which have a maximum CCA of 2000 ha (Rural water bodies) and satisfying the criteria of minimum 5 ha of water spread area in case of rural water bodies and 2-10 ha water spread area in case of urban water bodies are eligible to be included under the scheme RRR of water bodies. This is a continuing scheme since X Plan and is presently being implemented during XII Plan and onwards also.

In addition, Government of India has sanctioned a special package for completion of Irrigation Projects to address agrarian distress in Vidarbha and Marathwada and other chronically drought prone areas of Rest of Maharashtra during July, 2018. The package consists of 8 Major and Medium Irrigation (MMI) Projects approved by TAC of MoWR, RD & GR and 83 Surface Minor Irrigation (SMI) Projects. The balance estimated cost of projects of Maharashtra to be completed under this package is Rs 13651.61 Cr as on 01.04.2018, with Rs 3831.41 Cr being the Central Assistance (CA) by Government of India. On completion of the balance works of these projects, additional Irrigation Potential of 3.77 Lakh Ha would be created. Latur district of Maharashtra will be benefitted bycompletion of 03 Minor Schemes under special package namely (i) Borasuri Storage Tank, (ii) Vairagarh Storage Tank and (iii) Chondi Storage Tank.

During 2019, Ministry of Jal Shakti has launched Jal Shakti Abhiyan (JSA) - a campaign for water conservation and water security. During the campaign, officers, water experts and scientists from the Government of India will work together with State and district officials in India's water-stressed districts for water conservation and water resource management.

# Note on Pradhan Mantri Krishi Sinchayee Yojana (PMKSY)

Irrigation development being a state subject, planning, execution and operation & maintenance of irrigation projects including repairing and strengthening of dams, embankments and canals are carried out by the State Governments from their own resources and as per their own requirements and priority of works. The Union Government has launched Accelerated Irrigation Benefit Programme (AIBP) in 1996-97 for providing financial assistance with an objective of expediting the implementation of ongoing major, medium and Extension, Rennovation and Modernization (ERM) Irrigation Project including Lift Irrigation and Minor Irrigation Schemes for the schemes which are in advance stage and for which State Government is facing financial resource crunch. Total 297 nos. of MMI Projects have been included under AIBP out of which 143 nos have been completed as on 01.04.2015.

During 2015-16, Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) was launched by Union Government with an aim to enhance physical access of water on farm and expand cultivable area under assured irrigation, improve on farm water use efficiency, introduce sustainable water conservation practices etc. Under the PMKSY-AIBP, 99 priority projects have been identified out of ongoing 149 major / medium irrigation projects under AIBP with a dedicated funding mechanism to complete them in a time bound manner with the aim to be completed by Dec., 2019. Out of 99 priority projects, 34 MMI projects have been reported as completed under PMKSY-AIBP as on date. Under AIBP-PMKSY, a cumulative Central Assistance (CA) of Rs. 48327.80 Crore has been provided to these 99 priority projects till March 2019 and a cumulative irrigation potential of 5168.81 Th.Ha has been created till March 2018.

# Note on Drought Prone areas

Drought Prone areas are given priority under AIBP/PMKSY. Total 54 projects benefitting drought prone areas in 11 States are part of the 99 prioritized PMKSY-AIBP projects. Government of India provides central assistance with higher funding ratio to irrigation projects situated in drought prone areas.
