- Extension of bid validity, if required (vii)
- Recommendation of TEC put up after Technical bid evaluation (viii)
- Recommendation to Open Financial Bid (ix)
- Recommendation of TEC put up after Financial bid evaluation (x)
- Final Review of recommendations of TEC (xi)
- Vetting of Purchase Order/Letter of Intent (LoI)/Award of contract to be published (xii) on CPP Portal
- Forfeiture of EMD, in case applicable (xiii)
- (xiv) Tolerance clause
- In any material deviation to the terms of contract is envisaged at a later stage (xv)
- Extension of delivery period (xvi)
- (xvii) Recovery of Liquidated damages
