Background :

1. This is with reference to the on-line First Appeal no.- CWCND/A/E/20/00019 dated 30/05/2020 of Shri Rajesh Kumar Reddy

Rapolu, H No 9-56/1, Phase 1, Street 1, Venkatadri township, Chowdariguda, Ghatkesar, Telangana, Pin:500088 received on 03-06-2020 in the office of the First Appellant Authority, WP&P Wing, CWC, New Delhi, from Under Secretary & Nodal Officer, RTI, CWC, New Delhi on ground that " **Details not provided, No Response Within Time Limit**".

2. Under Secretary and Nodal Officer, Right to Information, Central Water Commission, New Delhi, vide his letter No A-49012/8/2017/RTI/336 dt 27/08/2018 also transferred this RTI application CWCND/R/2018/50148 dated 25-08-2018, under RTI Act 2005 to "Dir RMCD & CPIO RM Wing & Director D&RC, D&R Wing " of Central Water Commission.
3. The applicant, vide his application under RTI Act 2005, having No CWCND/R/2018/50148 dated 25-08-2018, which was received in this office on 27/08/2018 on transfer from Under Secretary & Nodal Officer for RTI, CWC, New Delhi vide No A-49012/8/2017/RTI/336 dt 27/08/2018 **had requested to provide the information is reproduced as under:**

" i. What are the water sources of Telangana State. How much water is allocated to Telangana from different rivers and How much is being use by different Projects of Telangana.

ii. How many water projects are under construction in Telangana State and What are the estimated costs, capacities of those projects (Like Drinking water, Cultivation, and Industrial purpose) and How much amount is sanctioned by both State Govt and Central Govt.

iii. How much land acquisition is required for construction of above projects and how much amount is giving or already given to them for acquisition.

iv. How many water projects of Telangana State are recognized as National projects and How many are requested for recognition. Which type of projects can be recognized as National Projects.

v. How much water is available for each month in different rivers of Telangana State. What are the best places for construction of Projects in Telangana State."

4. **As per section Section- 19 (1):** Any person who, does not receive a decision within the time specified in sub-section (1) or clause (a) of sub-section (3) of section 7, or is aggrieved by a decision of the Central Public Information Officer or State Public Information Officer, as the case may be, may within thirty days from the expiry of such period or from the receipt of such a decision prefer an appeal to such officer who is senior in rank to the Central Public Information Officer or State Public Information Officer as the case may be, in each Public Authority.

The applicant has not made his first appeal within 30 days.

5. CPIO of WP&P Wing of CWC vide office letter No I-57077/2/2018-WPP Coordination/I/2835/2018 dt 20/09/2020 has **sent the information as available in WP&P Wing of CWC to the applicant i.e. well within the time limit of 30days.(copy enclosed)**

6. In light of above, the application under RTI Act 2005 of Shri Rajesh Kumar Reddy Rapolu, H No 9-56/1, Phase 1, Street 1, Venkatadri township, Chowdariguda, Ghatkesar, Telangana, Pin:500088, which was received in WP&P Coordination Dte on 29/08/2018 shall be considered as settled under the provisions of Right to Information Act, 2005 by the Central Public Information Officer of Water Planning and Project Wing of Central Water Commission and No further action on the part of CPIO, WP&P Wing of CWC is required.
