OFFICE MEMORANDUM

Subject: Acceptance of caste/community certificates produced by Scheduled Caste candidates.

The undersigned is directed to refer to the subject mentioned above and to say that Government of West Bengal vide their letter No. 628-BCW/MR-208/13 dated 25.02.2020 has brought to the notice of this Department that though their format of caste certificate is in conformity with the format prescribed by the Government of India yet some recruitment authorities of Central Government are not accepting that and has prescribed a different format of caste certificate to be submitted by the candidates for obtaining benefit of reservation in recruitment under Government of India, which is causing harassment to Scheduled Caste (SC) candidates in addition to the burden of issuing of such duplicates often at very short intervals.

2. Owing to difficulties faced by candidates belonging to SC/ST categories in securing admission to professional colleges and employment in Public Sector Undertakings (PSUs) due to insistence by certain authorities to produce caste certificate in their format, the Ministry of Welfare's (Now Social Justice and Empowerment) vide O.M. No. 12025/18/94-SCD (R.L.Cell) dated 10.08.1994 has requested all the Ministries/ Departments to accept the caste certificate issued in the prescribed proforma by one of the authorities empowered to issue such certificate and not to ask SC/ST candidates to submit social status certificates in some other format. A copy of the O.M. dated 10.08.1994 is enclosed for ready reference.

3. It is therefore, re-iterated that the Scheduled Caste certificate issued by the following authorities in the prescribed format (enclosure to O.M. dated 10.08.1994) may be accepted by the appointing authorities as sufficient proof in support of a candidate's claim to belong to Scheduled Caste:-

- (i) District Magistrate/Additional District Magistrate/Collector /Deputy Commissioner/Additional Deputy Commissioner/ Deputy Collector/ 1st Class Stipendary Magistrate/City Magistrate/Sub Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner (not below the rank of 1st Class Stipendary Magistrate);
- (ii) Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/Presidency Magistrate;
- (iii) Revenue Officer not below the rank of Tehsildar;
- (iv) Sub-Divisional Officer of the area where the candidate and/or his family normally resides; and
- (v) Administrator/ Secretary to Administrator/Development Officer (Lakshdweep Islands).



4. All the Ministries/ Departments are again requested to bring the contents of this O.M. to the notice of all the recruiting authorities under their control and they may be advised not to ask the SC candidates to submit caste certificate in some other format.

OFFICE MEMORANDUM

Subject:-- Submission of SC/ST certificates by the Scheduled Castes/ Scheduled Tribes candidates in Public Sector Undertakings, Corporations, Banks, Medical/ Engineering Colleges, ONGC, etc.- acceptance of caste certificates issued by competent certificate issuing authority.

The undersigned is directed to say that instances have come to this Ministry's notice that candidates belonging to Scheduled Castes/ Scheduled Tribe communities face hardships in getting admission / appointment in Medical/ Engineering Colleges, Public Sector Undertakings/ Corporations, Banks, ONGC etc. as these organisations insist often Scheduled Caste and Scheduled Tribe candidates to submit their Scheduled Caste/ Scheduled Tribe certificate in the printed format supplied by them, Even though the candidates possess valid Scheduled Caste/ Scheduled Tribe certificates issued by competent certificate issuing authority. Instances have also come to notice that Scheduled Caste/ Scheduled Tribe candidates are directed by the appointing / educational authorities to get Scheduled Caste/ Scheduled Tribe certificates signed by officers who are not empowered to issue such certificates.

2. In this connection it is stated that this Ministry have already circulated to all the Ministries/ Departments the format of caste certificates to be issued to the Scheduled Caste/ scheduled Tribe candidates; and a list of authorities empowered to issue SC/ST certificates (copy enclosed) certificates issued by an authority other than those specified will not be accepted by the appointing authority. Department of Personnel and Training have also issued similar instructions to all the Central Ministries/ Departments.

3. All the Ministries/ Departments of Government of India are therefore, requested to strictly adhere to the format of caste certificate and the list of authorities empowered to issue Scheduled Caste/ Scheduled Tribe certificates. Submission of SC/St certificate by other authority need not be insisted in the cases of those SC/ST candidates who possess SC/ST certificates issued by the competent authorities in prescribed format. Ministries of Health and

Family Welfare, Human Resource Development (Department of Education) and Bureau of Public Enterprises are requested to kindly bring contents of those O.M. into the notice of all concerned.
