OFFICE ORDER

The approval of DoWR, RD & GR vide Letter No. A-51011/1/2019-E-I dated 13th July 2020 (copy enclosed) is conveyed herewith for the following internal re-Organization of Brahmaputra and Barak Basin Organization, Shillong:

- 1. A new Office of the Chief Engineer will be established at Guwahati, and named as **Brahmaputra Basin Organization (BBO)**, by transferring the post of Chief Engineer (CMO) to Guwahati from Central Water Commission Head Quarters. The said Office will function in the present Central Water Commission Complex in Guwahati.
- 2. The post of SE(C) in the Office of the Chief Engineer, Brahmaputra Basin Organization, Guwahati will be established by transferring the post of Director (CMC & P&M) under Chief Engineer (CMO) to Guwahati from CWC (HQ).
- 3. One post of PS to Chief Engineer, Brahmaputra Basin Organization, Guwahati and two posts of AD-II will also be transferred from CWC (HQ) to Brahmaputra Basin Organization, Guwahati. Ministerial staff required for the proposed Office of the Chief Engineer, Brahmaputra Basin Organization, Guwahati will be posted by the concerned Establishment.
- 4. The existing post of Chief Engineer, Brahmaputra & Barak Basin Organization, Shillong will be retained in Shillong itself and the Office will be renamed as **Barak & Other Basins Organization (B&OBO)**.
- 5. Cadre management of all the existing Work Charged Staff will remain attached to the current circles, namely SE, HoC, Guwahati or SE, MC, Silcher or SE, NEIC, Shillong as the case may be, after the internal re-organization of B&BBO is implemented. In case of any fresh recruitment of Work Charged Staff by any of the circles under Brahmaputra Basin Organization, Guwahati or Barak & other Basins Organization, Shillong, cadre management and administrative control of such staff will be vested with the said circle.
- 6. Chief Engineer, B&BBO, Shillong may extend the necessary logistical support to facilitate the opening of the Office of the Chief Engineer, Brahmaputra Basin Organization, Guwahati.
- 7. The structure of the two Organizations namely Brahmaputra Basin Organization, Guwahati and Barak & Other Basins Organization, Shillong after reorganization of B&BBO is enclosed at **Annexure A**.
