Background:

1. This is with reference to the on-line First Appeal no.- CWCND/A/E/20/00029 dated 10/08/2020 of Shri V Ramesh Chandra Varma, 10-209, Ravindra Raju Nagar, K Agraharam, East Godavai Distt Amalapuram, AP Pin 533201 received on 24-08-2020in the office of the First Appellant Authority, WP&P Wing, CWC,

- New Delhi, from Under Secretary & Nodal Officer, RTI, CWC, New Delhi on ground that " Details not provided, No Response Within Time Limit".
- Under Secretary and Nodal Officer, Right to Information, Central Water Commission, New Delhi, vide his letter No A-49012/8/2020/RTI/113 dt 06/07/2020 also transferred this RTI application No CWCND/R/E/20/00098dated03-07-2020, under RTI Act 2005 to "Dir RMCD & CPIO RM Wing & Director D&RC & CPIO, D&R Wing " of Central Water Commission.
- 3. The applicant, vide his application under RTI Act 2005, having No CWCND/R/E/20/00098dated03-07-2020, which was received in this office on 07/07/2020on transfer from Under Secretary &Nodal Officer for RTI, CWC, New Delhi vide No A-49012/8/2020/RTI/113 dt 06/07/2020 had requested to provide the information is reproduced as under:
 - i) What is the fundamental objective of the scheme of National Project (Irrigation) approved by the Government of India in February, 2008 and whether the Comptroller and Auditor General of India in its report on National Projects (Performance Audit) issued in 2018 had made observations that there is tardy implementation and cost escalation of the National Project identified under the scheme resulting in administrative delays in Land Acquisition and there is insufficient rehabilitation and resettlement (RR) in project displaced families as a result there is payment of interest arising from delayed payment of compensation of RR as a result adversely impacting strategic national interests. If yes, please provide a copy of the decisions orders of the Central Government taken in this regard to expedite the process of implementation of the scheme of National Projects.
 - ii)Please provide a copy of the details information with respect to number of projects under implementation as on date today under the scheme of National Projects
 - iii) Please provide a copy of the details information regarding proposals sent to the Central Water Commission for Command Area Development of the project under implementation under the scheme of National Projects
 - iv) Please provide a copy of the National Projects approved by the Union Cabinet in February, 2008 also provide a copy of the decision and/or

- reason of the Union Cabinet to continue the scheme of National projects during the XII (2012-2017
- v) Please provide a copy of the details information with respect to proposed actual release of funds for the years 2018-19 and 2019-20 for completion of the projects under implementation as per the scheme of National Projects. "
- 4. As per section Section- 19 (1): Any person who, does not receive a decision within the time specified in sub-section (1) or clause (a) of sub-section (3) of section 7, or is aggrieved by a decision of the Central Public Information Officer or State Public Information Officer, as the case may be, may within thirty days from the expiry of such period or from the receipt of such a decision prefer an appeal to such officer who is senior in rank to the Central Public Information Officer or State Public Information Officer as the case may be, in each Public Authority.
- E. CPIO of WP&P Wing of CWC vide office letter No I-12011/42/2019-WPP Coordination/I/25353/2020 dt 31/07/2020.has sent the information except "Meeting of Cabinet Committee on Economic Affairs (CCEA) was held on 12th September, 2013 regarding continuation of National Projects in XII Plan". As the document was of secret nature and is exempted under Section 8(1) (ix) of RTI Act. However it was brought in knowledge to the applicant that the decision to continue the scheme of National projects was taken in the meeting." as available in WP&P Wing of CWC to the applicant i.e. well within the time limit of 30days
- 5. In light of above, the application under RTI Act 2005 of Shri V Ramesh Chandra Varma, 10-209, Ravindra Raju Nagar, K Agraharam, East Godavai Distt Amalapuram, AP Pin 533201 which was received in WP&P Coordination Dte on 07/07/2020 shall be considered as settled under the provisions of Right to Information Act, 2005 by the Central Public Information Officer of Water Planning and Project Wing of Central Water Commission and No further action on the part of CPIO, WP&P Wing of CWC is required.

6. Decision

In view of the above, CPIO, WP&P Wing of CWC has acted in accordance to the provisions of RTI Act, 2005 and sent the reply at the earliest to the applicant.(copy of reply sent is enclosed)

In the light of the above, the First Appeal having registration NoCWCND/A/E/20/00029, dated 10/08/2020 of Shri V Ramesh Chandra Varma, is hereby dismissed.
