How much Central & State Government bearing expenses? What are benefits of Kaleshwaram Project.	No information w.r.t. Central & State Governments Expenditure is available in this office. As per the DPR of this project, it is having Culturable Command Area (CCA) of 738851Ha and annual irrigation of 961497 Ha with intensity of irrigation as 130.13%. Further, this project will stabilize 762028 Ha of land of other existing projects of Telangana State. In addition to this, this project will provide 40TMC (1133 MCM) of drinking water to Hyderabad, Secunderabad and villages en-route and 16 TMC (453 MCM) of industrial water.
