## Background:

1. This is with reference to the on-line First Appeal no.- CWCND/A/E/20/00042 dated 18/11/2020 of Shri Naresh Kumar, H No 134, ST3 Bobby Colony, Hambran Road, Punjab Pin 141008 received on 20-11-2020 in the office of the First Appellant Authority, WP&P Wing, CWC, New Delhi, from Under Secretary & Nodal Officer, RTI, CWC, New Delhi on ground that " Details not provided, No Response Within Time Limit".

- 2. The RTI application having No CWCND/R/T/20/00099 dated 12-10 2020-was received in office of the Dir & CPIO, WP&P Coordination Directorate on transfer from Under Secretary and Nodal Officer, Right to Information, Central Water Commission, New Delhi, vide his letter No A-49012/8/2020/RTI/246 dt 12/10/2020. Under Secretary and Nodal Officer, Right to Information also transferred this RTI application to SE (Coord)& CPIO, IBO, Chandigarh, under RTI Act 2005 of Central Water Commission. The First Appeal no.- CWCND/A/E/20/00042 dated 18/11/2020 of Shri Naresh Kumar, has also been transferred to First Appellant Authority, i.e CE, IBO, Chandigarh.
- 3. The applicant, vide his application under RTI Act 2005, having CWCND/R/T/20/00099 dated 12-102020-, which was received in this office on 12/10/2020 on transfer from Under Secretary & Nodal Officer for RTI, CWC, New Delhi vide No A-49012/8/2020/RTI/246 dt 12/10/2020 had requested to provide the information is reproduced as under:
  - "How much centre Government of India and State Government of Punjab Spent on "Budda Nalla" or "Ganda Nalla" situated at Ludhiana Started from village Kumkalan Ludhiana and after crossing from city area of Ludhiana and then converted into most dangerous polluted water and converted into "budda dariya" to "budda nalla"and fell into Satluj from village wazipur Kalan Ludhiana. A report on it How much budda dariya cleaned after spenting that money. I need full report from 1990 to September 2020"
- 4. While scrutinizing the correspondence made, it is found that the above RTI application was received in WP&P Coordination Dte. on 12/10/2020, was further forwarded to provide material for reply to Dir, PA North, EM & Mon EW, Directorate vide this office letter No I-12011/115/2020-WPP Coordination/I/33369/2020 dt 11/10/2020. The reply to the above said application was to be given by 10<sup>th</sup> Nov.2020 i.e. within 30 days from the date of receipt of the application
- CPIO of WP&P Wing of CWC vide office letter No.I-12011/115/WPP Coord/I/36860/2020 dated 05/11/2020 has sent his reply to the applicant well within the time limit of 30days (copy enclosed)
- 6. In light of above, the application under RTI Act 2005 of Shri Naresh Kumar, H No 134, ST3 Bobby Colony, Hambran Road, Punjab Pin 141008 E mail: accbookshop1@gmail.com which was received in WP&P Coordination Dte on

12/10/2020 shall be considered as settled under the provisions of Right to Information Act, 2005 by the Central Public Information Officer of Water Planning and Project Wing of Central Water Commission and No further action on the part of CPIO, WP&P Wing of CWC is required.

## 7. Decision

In view of the above, CPIO, WP&P Wing of CWC has acted in accordance to the provisions of RTI Act, 2005 and sent the reply at the earliest to the applicant. In the light of the above, the First Appeal No CWCND/A/E/20/00042, dated 18/11/2020 of Shri Naresh Kumar, is hereby dismissed.
