This is to informed that this office is in advance stage of procurement of 60 numbers of laptops vide OM mentioned in above reference for the officers as per list at Annexure-I.

Procurement of new laptops for other eligible officers is being planned by this office. For this purpose, a list of eligible officers has been prepared (Annexure-II). Few officers have put a request for new laptop but have not retained previously issued laptop. All these officers are kindly requested to send both the requests through an email to smdte@nic.in by 14.12.2020. The eligible officers whose name is not yet included in the lists in the Annexure (I & II) may also please send their requisitions along with functional justification.

It may be noted that functional justification is required to be submitted along with request for a new laptop. For retention of previously issued laptop, 10% residual value is to be paid. Such payments are to be made in the form of a cheque in favour of "DDO-II Central Water Commission" for HQ and for Regional offices from their concerned DDO. The same original receipt issued by DDO is to be submitted to SMD.

The new requisition of the officers who have already issued laptops may be considered only after retention of previous device and as per instruction of Department of Expenditure OM No. F. No. 8(64)/2016-E.II (A) dated 27-09-2016. For more clarity, a case-wise questionnaire along with process to follow as per applicability of case has been prepared and attached at Annexure-III.

In case of any discrepancy in the list attached in Annexure, this office may kindly be informed at the earliest.
