**Background :**

1. This is with reference to the on-line First Appeal no.- CWCND/A/E/20/00045 dated 29/11/2020 of Shri Sravan Kumar K, 2<sup>nd</sup> Floor, 6461 Block 8 Lane-3, Dev Nagar Karolbagh New Delhi,—110005, received on 02-12-2020 in the office of the First Appellant Authority, WP&P Wing, CWC, New Delhi, from Under Secretary & Nodal Officer, RTI, CWC, New Delhi on ground that **“Any other ground - complete information not provided ”**.

2. The RTI application having No CWCND/R/T/20/00109 dated 27/10/2020 was received in office of the Dir & CPIO, WP&P Coordination Directorate on transfer from Under Secretary and Nodal Officer, Right to Information, Central Water Commission, New Delhi, vide his letter No A-49012/8/2020/RTI/283 dt 27/10/2020. Under Secretary and Nodal Officer, Right to Information also transferred this RTI application to SE (Coord)& CPIO, KG, Hyderabad and Director(RMCD) & COPIO RM Wing under RTI Act 2005 of Central Water Commission. The First Appeal no.- CWCND/A/E/20/00045 dated 29/11/2020 of Shri Sravan Kumar K, has also been transferred to First Appellate Authority, i.e CE, (FMO), New Delhi & CE KGBO Hyderabad.

3. The applicant, vide his application under RTI Act 2005, having No CWCND/R/T/20/00109 dated 27/10/2020, which was received in this office on 29/10/2020 on transfer from Under Secretary & Nodal Officer for RTI, CWC, New Delhi vide No A-49012/8/2020/RTI/283 dt 27/10/2020 **had requested to provide the information is reproduced as under:**

- i Copies of communications on the implementation of directions of National Green Tribunal in O.A. No. 110 of 2019. Ponguleti Sudhakar Reddy Vs State of Telangana
- ii Copies of Minutes of meeting conducted in accordance with the direction in GA No. 11 0 of 2019 by the Union Jal Shakti Ministry with State of Telangana. Andhra Pradesh, Odisha, Chhattisgarh, Polavaram Project Authority, Ministry of Environment. Forest and Climate Change, Central Water Commission.
- iii Copies of communications received by Jal Shakti ministry, CWC on Polavaram Project from State of Telangana, Odisha, Chhattisgarh on the implementation of OA 110 / 2019
- iv Copies of reports relating to effect of Polavaram Irrigation Project on Telangana, Odisha & Chhattisgarh ”

E. “As per RTI Act, 2005, a citizen has a right to seek such information from a public authority which is held by the public authority or which is held under its control. It is important to note that only such information can be supplied under the Act which already exists and is held by the public authority or held under the control of the public authority. The Public Information Officer is not supposed to create information; or to interpret information; or to solve the problems raised by the applicants;”.

The reply to the above said application was to be given by 25<sup>th</sup> Nov 2020 i.e. within 30 days from the date of receipt of the application

5. CPIO of WP&P Wing of CWC vide this office letter **No.I-12011/115/WPP Coord/I/38669/2020 dated 25/11/2020** has provided the available information against point No 1,2,3 of the RTI application. In regard with information sought by the

applicant under his RTI application against point No4, the applicant was advised to contact concern authority i.e. Director (CPCB)2nd Floor, No.77-A, South Avenue Road, Ambattur Industrial Estate, Ambattur Taluk, Thiruvallur District, Chennai- 600 058, to obtain information, i.e., **well within the time limit of 30 days (copy enclosed)**

6. In light of above, the application under RTI Act 2005 of Shri Sravan Kumar K, 2<sup>nd</sup> Floor, 6461 Block 8 Lane-3, Dev Nagar Karolbagh New Delhi,-110005. Email: advsravan@gmail.com which was received in WP&P Coordination Dte on 29/10/2020 shall be considered as settled under the provisions of Right to Information Act, 2005 by the Central Public Information Officer of Water Planning and Project Wing of Central Water Commission and No further action on the part of CPIO, WP&P Wing of CWC is required.

## 7. Decision

In view of the above, CPIO, WP&P Wing of CWC has acted in accordance to the provisions of RTI Act, 2005 and sent the reply at the earliest to the applicant.

In the light of the above, the First Appeal No CWCND/A/E/20/00042, dated 18/11/2020 of Shri Sravan Kumar K, is hereby considered as settled.
