Irrigation being a state subject, the State Government plan, accord sanction and implement irrigation projects as per their periotity, needs and resources. To supplement the efforts of the State the Union Government had launched Accelerated Irrigation Benefit Programme (AIBP) in 1996-97 for providing financial assistance with an objective to expedite the implementation of ongoing major, medium Irrigation Project which are in advance stage of construction and for which State Government is facing financial resource crunch. In the year 2014-15, 149 major and medium irrigation projects were ongoing under AIBP. During 2015-16 Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) has been conceived by the Central Government with an aim to enhance physical access of water on farm and expand cultivable area under assured irrigation, improve on farm water use efficiency, introduce sustainable water conservation practices etc to produce per drop more crop', thus bringing much desired rural prosperity. The programmes as being implemented by the Govt. of India, viz Accelerated Irrigation Benefits Programmes (AIBP); Repair, Renovation and

Restoration (RRR) and Command Area Development and Water Management (CADWM) have been subsumed in PMKSY. On consultation with the concerned State Governments, 99 projects were identified as priority projects under PMKSY-AIBP amongst 149 on-going projects under AIBP with a dedicated funding mechanism to complete these projects in a time bound manner. Out of these 99 priority projects, 44 projects have been reported as completed by March 2020. A list of these 99 priority projects with their respective benefits in terms of Irrigation Potential is given in enclosed **Annexure -I.**

In addition, Government of India has sanctioned a special package for completion of Irrigation Projects to address agrarian distress in Vidarbha and Marathwada and other chronically drought prone areas of Rest of Maharashtra during July, 2018. The package consists of 8 Major and Medium Irrigation (MMI) Projects approved by TAC of MoWR, RD & GR and 83 Surface Minor Irrigation (SMI) Projects. The balance estimated cost of projects of Maharashtra to be completed under this package is Rs 13651.61 Cr as on 01.04.2018, with Rs 3831.41 Cr being the Central Assistance (CA) by Government of India. On completion of the balance works of these projects, additional Irrigation Potential of 3.77 Lakh Ha would be created. Project-wise details of these 8 Major and Medium Irrigation projects indicating Irrigation Potential are given in enclosed as **Annex-II**
