It is learnt that At present CWC are going to give ADHOC promotion Does not come under the purview of from JE to AD-2, why CWC not giving regular promotion from JE to RTI Act, 2005 AD-2 despite in last time they have done regular promotion from JE to AD-2.		
 If the judgement in case of Sh. S.Sambhashiv Rao, AD-II Does not come under the purview of RTI Act, (RETD.) has dismissed or stayed by HIGH COURT, Hyderabad 2005 then CWC will give regular promotion from AD-2 to AD & regularize AD(Adhoc) to AD, if not so the reason thereof.		
Why CWC is not freezing the seniority of AD due to 50:50 Does not come under the purview of RTI Act, ratio quota from DPC/DR is not being fulfilled by CWC since 2005 long back upto resolving the issue or regularization of promotions from AD-2 to AD & give the copies of rule positions/RR in this regard.
