With reference to above RTI Application, which is received in this office on dt 31-03-2021 on transfer from Under Secretary & Nodal for RTI, CWC, New Delhi, vide letter A-49012/8/2021/RTI/109 dated 31/03/2021 the information, as available in WP&P Wing of CWC, is as under:

	Initially, the special category status announced by Parliament to Andhra Pradesh State. But later on, it is converted to a special package by Parliament. My question is:	Details of grant of any Special Package to Andhra Pradesh are not available in WP&P Wing. WP&P Wing, CWC deals with the ongoing Major and Medium Irrigation (MMI) Projects, which are part of the Pradhan Mantri Krishi Sinchayee Yojana – Accelerated Irrigation Benefits Programme (PMKSY-AIBP), a Centrally Sponsored Scheme. Under PMKSY-AIBP, 99- Major and Medium Irrigation (MMI) projects have been identified in consultation with the State Government. Central assistance is released to the project as per guidelines of the scheme. Project-wise details of Central Assistance released and districts benefitted under PMKSY-AIBP in various states of the country including Andhra Pradesh are given at <b>Annexure-I</b>
1	How much amount of funds are given to Andhra Pradesh compared with all other states (I mean the States without special status package as a part of a Special package rather than normal grants)?.	
2	How much amount of funds are given to Rayalaseema and North Andhra districts similar to the Bundelkhand package announced by Parliament?	
3	How much amount of funds are given to Polavaram National Project and why the funds are getting delayed? How is responsible for the delay Central Government or State Government?	it is to mention that Polavaram Irrigation Project (PIP) was declared as National Project by Andhra Pradesh Reorganization Act, 2014. The Government of India is reimbursing the expenditure incurred by the State with effect from 01.04.2014 as per Ministry of Finance Office Memorandum No. F. No. 1 (2) / PF-I/2014 (Pt) dated 30.09.2016, "The Central Government will provide 100% of the remaining cost of the irrigation component only of the PIP for the period starting 01.01.2014, to the extent of the cost of the irrigation component on that date".  As per 2nd RCC, the cost of irrigation component at PL 2013-14 for approved quantities of RCE 2010-11 is Rs. 20,398.61

So remaining amount of Rs. 15,667.90 Cr (irrigation component) is to be reimbursed by Govt. of India. Out of which Central Assistance (CA) of Rs. 10,848.352 has been reimbursed towards PIP, as per information available in this office.</p> <p>Govt of India reimburses the expenditure incurred by WRD, GoAP based on scrutiny of bills &amp; recommendation of PPA and Central Water Commission (CWC) to Ministry of Jal Shakti. Presently, funds are being provided for PIP through National Bank for Agriculture and Rural Development (NABARD) under Long Term Irrigation Fund (LTIF).</p>
