1	The list of water bodies in India by providing its survey number, area coverage details, and its boundary details.	Under India-WRIS project, water bodies of size more than 0.01 ha have been mapped using satellite imageries of 2009-10. As per the mapping, total number of Surface water bodies in the country are 7,96,588. Out of which, there are 1,27,288 Lakes / ponds. The State-wise details of the same are enclosed at Annexure -I. Further, DoWR, RD & GR, MoJS is conducting the Minor Irrigation Census on quinquennial basis (every 5 year). During 5th Minor Irrigation census with Reference Year 2013-14, the number of Surface flow schemes (Reservoirs, Tanks/Ponds, Other storages, Permanent / Temporary diversions, Water conservation cum ground water recharge schemes/ Percolation Tanks/ Check dams etc.,) have also been collected. "Repair, Renovation & Restoration Water **Bodies** of Encroachment on Water Bodies and Steps Required to Remove the Encroachment and Restore the Water Bodies", Guidelines for conservation & protection of water bodies have been prepared and submitted to DoWR, RD&GR, Ministry of Jal Shakti (erstwhile Ministry of Water Resources, RD & GR), New Delhi vide CWC(HQ) letter dated 15.6.17 for further necessary action. Further, as per the Guidelines for the scheme on Repair, Renovation and Restoration (RRR) of water bodies under PMKSY (HKKP), State Government is to take necessary steps for declaring the water body boundary through a Government order and ensure removal of encroachments in the water body spread area/water body boundary before submitting the proposal for release of 2nd installment of grant for completion of work on the water body under RRR.

In the context, it is also informed that water being a State subject and the planning, execution and operation and management of Irrigation Projects are carried out by the State Government from their own resources and as per their requirement and priority of works.
