Terms & conditions:

- 1. As prescribed vide Ministry of Finance order No. F. No. 24(3)/E.Coord/2018, dtd 26.03.2018 the rate of reimbursement is limited to Rs 1200/- per month (excluding taxes). Any revisions in the ceiling of Rs.1200/- by MoF shall be automatically applicable.
- 2. Chairman (CWC) has approved to grant residential telephone facility to 3 Assistant Directors (FFM) based on their functional requirement. Two out of those have been accommodated under S. No. 32 of the table above and third one will be given this facility out of the quota kept as 'Reserved Slots'.
- 3. Against 8 nos. sanctioned posts of Under Secretary (US) there are 10 incumbents presently posted in CWC. So, out of 10 incumbents, 8 nos. have been accommodated under S. No. 7 of the table above. Rest 02 nos. of US will be given this facility out of the 'Reserve Slots'.
- 4. This revised list of eligible officers shall be made effective from 2nd quarter of the current Financial Year 2021-22.

- 5. If a Senior-Most DD of CWC (HQ) becomes eligible for the facility on functional basis, he/she will be allowed to avail this facility on functional basis only and he/she will be removed from the list of Senior-most DDs. At the same time, the list of senior-most DDs shall be revised to add a new senior-most DD in the list of eligible offices.
- 6. The list of eligible officers during a quarter shall be prepared at the end of that particular quarter.
- 7. Any further alteration or addition of eligible officers that may arise in future can be done with the approval of Chairman CWC through Chief Engineer (HRM) subject to the condition that there is no change in sanctioned strength of Group 'A' officers (680 nos.) and as such the total number of eligible officers below the rank of Dy. Secretary does not exceed 170 (i.e. 25%. of 680).
