The undersigned is directed to say that the post of Deputy Director General(Engineering)(General Central Service, Group 'A' Gazetted, Non-Ministerial) in Pay Band-4 of Rs.37400-67000/- plus Grade Pay of Rs.8700/-, as per 6th CPC (Level 13(118500-214100), as per 7th CPC), is proposed to be filled up in Fishery Survey of India, Mumbai, a sub-ordinate office under the administrative control of the Department of Animal Husbandry, Dairying and Fisheries, Ministry of Agriculture and Farmers Welfare by composite method(Deputation plus promotion) from amongst the officers under the Central Government or State Governments or Union Territories:-

- (A)(i) holding analogous posts on regular basis in the parent cadre or Department, or
(ii) with five years' service in the grade rendered after appointment thereto on a regular basis in the Pay Band-3 of Rs.15600-39100/- plus grade pay of Rs.7600/-, as per 6th CPC (in Level 12(78800-209200)) or equivalent in the parent cadre or Department; and

(B)possessing the following educational qualifications and experience:

- (i) Degree in Mechanical or Marine Engineering from a recognized University; or
certificate of Competency of Marine Engineer Officer Class-I(Steam or Motor or combined Steam and Motor);
- (ii) 12 years' experience of repair or maintenance or construction of deep sea fishing vessels(including under water repairs)



2. The Departmental Director(Engineering) in Pay Band-3 of Rs.15600-39100/- plus Grade Pay of Rs.7600/-, as per 6th CPC (in Level 12 (78800-209200), as per 7th CPC), with five years' regular service in the grade will also be considered along with outsiders and in case he is selected for appointment to the post, the same shall be deemed to have been filled by promotion.
3. For the purpose of computing minimum qualifying service for promotion, the service rendered on a regular basis by an officer prior to 1st January, 2006 the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended, shall be deemed to be service rendered in the corresponding Grade Pay or Pay Scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any up-gradation.
4. The Departmental Officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on Deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
5. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not to exceed five years. The maximum age limit for appointment by Deputation shall not be exceeding 56 years as on the closing date of receipt of application.
6. Duties and responsibilities of the post in brief are as follows:-
 - (i) Head of the Engineering Division of the Institute.
 - (ii) As Head of the Division responsible for planning, scheduling and monitoring the routine, planned and breakdown maintenance repairs of the machinery of the vessels and other shore machinery.
 - (iii) Responsible for the proper functioning of the departmental workshops and their optimum utilization.
 - (iv) Guiding the Mechanical Marine Engineers and Service Engineers(Mech) and other Engineering Officers working at Headquarters and Base Offices in technical matters.
 - (v) Responsible for overall inventory control of spares, tools, equipments, etc. and timely procurement and proper storage of imported stores.
 - (vi) Planning and implementing of development activities like setting up of infrastructure facilities, acquisition of vessels, etc.
 - (vii) Preparation of budget, annual report and other technical reports in respect of Engineering Section of the Headquarters.
 - (viii) Technical guidance in dealing with the matters pertaining to the Engineering, Administration and Accounts matters.
 - (ix) Participating in technical committees of the Institute.
 - (x) Maintaining a liaison with Director General(Shipping)/MMD regarding registration of the vessels and other statutory requirements.



- (xi) Periodical inspection of the Base Offices.
- (xii) Organising in-house training programme for the engineering staff of Fishery Survey of India.


