Whether the construction of Shahpurkandi Dam project in pathankot will obstruct or affect the regular inflow of water into Pong Dam from the rivers of Ravi and Beas	Specific information sought is not available in this office. However, it is stated that Shahpurkandi Dam Project is being constructed on River Ravi 11KM downstream of Ranjit Sagar Dam and 6 Km upstream of Madhopur headworks to provide a balancing reservoir to ensure optimum utilization both for Irrigation in the canal system taking off from Madhopur Headworks & Ravi Canal (J&K) and Power generation at Ranjit Sagar Dam Power House. But the Pong Dam is an earth-fill embankment dam on the Beas River in the state of Himachal Pradesh India.
