- 1. (1) These rules may be called the Central Civil Services (Leave) Fourth Amendment Rules, 2013.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Central Civil Services (Leave) Rules, 1972, in rule 53, in sub-rule (a) in Forms 7 and 8, after para 4, the following para shall respectively, be

inserted, namely:-
