Out of these 99 MMI projects, 8 projects are from the state of Andhra Pradesh. The details of Central Assistance (CA) sanctioned by DoWR, RD & GR, Govt. of India towards these eight nos. of Project under PMKSY-AIBP are appended at Annexure-1.
