Ujh MPP Project has been accepted by Advisory Committee of DoWR, RD & GR in the 148th TAC meeting held on 17.01.2022 for Rs 11907.77 Cr at PL 2019 PL. Investment Clearance, EFC Note and Cabinet Approval are yet to be obtained for aforesaid cost.
2.	Whether the construction of Ujh Multipurpose Dam Project is allotted to NEEPCO or like other agencies?	As per information available in this office, Executing Agency for the Ujh Multipurpose Project is yet to be finalized.
3.	Tentative date of construction of Ujh Multipurpose Project in District Kathua J&K has been fixed?	Construction of the project will start after the approval of Cabinet. As per TAC Note for 148th Meeting by Advisory Committee of DoWR, RD & GR, the completion timeline for the project after start of the construction is 78 Months including 06 months for obtaining requisite Statutory Clearance, etc.
4.	Whether the exact plan for relief, rehabilitation and settlement around 3700 families who are undersubmergence is prepared under the Relief and Rehabilitation Act 2013 Govt. of India?	The exact plan for relief, rehabilitation and settlement for the project is under process by project authority (J&K). Requisite information may be sought from the Project Authority.
