1.	What is the OFFICIAL Total length of Ganges river in India?	As per the Central Water Commission (CWC) report "Reassessment of Water Availability in India using Space Input" published in June 2019.
2.	What is the name of the starting point and ending point of Ganges river in Indian OFFICIAL geographical map? (I mean From where to where in OFFICIAL)	River Ganga rises in the Gangotri glacier in the Himalayas at an elevation of about 7,010 m in the Uttarkashi district of Uttarakhand. At its source, the river is called as the Bhagirathi. It descends down the valley upto Devprayag where after joining another hill stream Alaknanda, it is called Ganga. The total length of river Ganga (measured along the Bhagirathi and the Hooghly) up to its outfall into Bay of Bengal is 2,525 km.
3.	Kindly send me a soft copy in official map of Ganges river total length (From where to where is).	The relevant page of the report is attached at Annexure.
