Later, Cabinet Committee on Infrastructure approved inclusion of Saryu Nahar Pariyojana in the scheme of National Project on 3rd August, 2012. Subsequently, Govt. of India under Section 90 of 'Andhra Pradesh Re-Organization Act' dated 01.03.2014, declared Polavaram Irrigation Project as 'National Project'. The details of 16 National Projects are attached as Annexure-IV.
