Planning, development and management of water resources projects are done by the concerned State Government based on their own resources& priority. The central government provides technical and financial support on a case by case basis through various schemes like AIBP, FMP and PMKSY based on the proposals of the respective State Government.
2.	Please give me details of all the canals present in District - Bhojpur, State -Bihar.	Two (2) projects from Bihar State namely ERM of Sone Canal Project and Bansagar Reservoir Project, were being funded under AIBP Scheme. These projects are benefiting Bhojpur District. Details of these projects are attached as Appendix .
