The DoWR, RD & GR, New Delhi has after considering these representations stated vide Letter No. A-32012/12/2022-E-I Section - MoWR dated 21.09.2022 that the same have not been agreed to by the competent authority due to the reason that services rendered on ad hoc basis are not counted for the purpose of seniority in the grade, or for promotion to the next higher grade. This is clearly mentioned in the order of ad-hoc promotion that grant of ad hoc promotion will not confer any right for consideration of regular promotion to that grade.

Accordingly, all representations submitted on seeking grant of regular promotion as AD/AEE and resultant financial benefits of regular AD/AEE from the retrospective date by the above mentioned officers are being treated as rejected and disposed of.
