With reference to above RTI Application, which was transferred to this office from Under Secretary & Nodal Officer, RTI cell, CWC, New Delhi on 12/10/2022, vide letter no.A-49012/8/2022/RTI/421 dated 12/10/2022, it is to mention that as per RTI act, public authority under the RTI Act is not supposed to create information; or to interpret information; or to solve the problems raised by the applicants; or to furnish replies to hypothetical questions. Only such information can be had under the Act which already exists with the public authority. The available information on the project is as follows:

ii) Farmers land compensation per acre on both Nagpur Bhandara District and home compensation.

उपलब्ध सूचना : As per the Monitoring Report submitted by MCO, CWC, Nagpur in December, 2019, the fully affected villages to be rehabilitated are provided compensation as per Maharashtra resettlement act 1986 and 5 additional civic amenities provided as per Maharashtra resettlement act 1999. Further, in view of demand of Project Affected Persons (PAPs) of Gosikhurd Irrigation Project (a National Project), Government of Maharashtra has declared Special Packages of Rs 152.00 Crore and Rs 1199.60 Crore vide Government Resolutions dated 02.02.2010 and 18.06.2013, respectively. The main provisions under packages are as under: -

Package dated 2/2/2010 (Rs 152 Crore):

- Interest on delay in payment after declaration of award of acquired land (Rs 71.29 Crore).
- Construction of shopping complex at new gaonthan to the tune of one shop for 25 families for employment generation (Rs 6.02 Crore).
- Technical training for our person from each family for employment generation (Rs 14.62 Crore).
- Aid through & as per cost norms of Indira Aawas Yojna for construction of houses in new gaonthan. (Rs 60.18 Crore).

Package dated 18/6/2013 (Rs 1199.60 Crore):

- Compensation in lieu of alternative land (Rs 405.25 Crore).
- Rehabilitation grant (Rs 195.35 Crore).
- Financial assistance for construction of cattle shed (Rs 15.87 Crore).
- Cash compensation in lieu of employment / job in Govt. sector (Rs 534.87 Crore)
- Aid for construction of houses to increased families (Rs 24.70 Crore).

For implementation of above package, revenue Department of state and VIDC has prepared a program for disbursement of package money and rehabilitation of PAPs. The Govt. of Maharashtra by G.R. dated 19/6/2013 has given approval for formation of special unit of 120 officer and staff for two years i.e. up to 31/3/2015.

उपलब्ध सूचना : The project was accepted by the Technical Advisory Committee (TAC) in its meeting held on 12.04.1988 for Rs 461.19 Crore at Price Level (PL) 1981-82, which was approved by the Planning Commission, Govt. of India on November 2, 1995. Subsequently, cost of the project was updated at PL 2007-08 PL for Rs 7777.85 Crore, which was approved by the erstwhile Planning Commission, Govt. of India on May 14, 2008 after its acceptance by TAC in its 92nd meeting held on February 27, 2008. The Project was included under National Project by Ministry of Water Resources vide MoWR letter no. 27/1/2005-PR, dated 26.02.2009 for balance works with estimated cost of Rs 4458.87 Crore.

Further, project cost was revised (@ PL. 2012-13 of WRD and 2013-14 of PWD) for Rs 18494.57 Crore with the cost of works of Rs 17078.60 Crore), which has been approved by State Level Technical Advisory committee (SLTAC) in its 61st meeting on 27 & 28 October 2015 and the 3rd Revised Administrative Approval (RAA) has been accorded by Government of Maharashtra vide letter No. RAA/2016/(394/2016)/MP-2 dated 21st September, 2016. The Fast Track Proforma Clearance (FTPC) proposal of the aforesaid revised cost was examined in CWC and Fast Track Proforma Clearance to the project was accorded vide CWC Office Memorandum NO CWC U. O. NO.4/1/2013/NP-II/VOL-VII/1802-1814 dated 11th December, 2017 read with corrigendum dated 8th January, 2018 for the cost of project including cost of works under National Project as detailed below.
