Subject: Inordinate delay in issue of PPOs to the employees of CWC

Sir,

This is in connection with inordinate delay in issue of PPOs to the retired officers/officials of CWC. In this regard, a review meeting was held by Secretary, Pension Pensioners' Welfare 2nd January, 2023 of & on Secretary(Pension&Pensioners' Welfare) had expressed serious concern about the pendency of such high number of pension cases. Also, a meeting was Secretary(DoWR,RD&GR)) on 17.1.2023, in which one of the agenda items discussed were issue of PPOs, which were pending for a considerable period of time. Secretary (DoWR, RD&GR) expressed his concern in the matter and has desired that expeditious action be taken to issue PPOs to the retirees and the time-line for issue of PPOs be adhered to. Further, It has been observed that no time schedule fixed by the Deptt of Pension & Pensioners'Welfare is being adhered to by the CWC in processing the pension cases. DoWR, RD & GR has been indicated among 'top ten Departments having case behind schedule' so far as issue of delayed PPO are concerned vide D.O. letter of Secretary, DoP&PW dated 02/12/2022(copy enclosed).

- 2. Besides, in the meeting taken by Secretary(DoWR, RD&GR) on 17.2.2023, it was noted that out of 67 pending cases (for the year 2022), 57 pertained to work-charged staff. It has been strictly instructed by Secretary (DoWR, RD&GR) for periodical review of these pendency at CWC level to put all out efforts to expedite the matter.
- 3. Since pension cases of work-charged staff and other non-gazetted employees is being dealt at division level under the jurisdiction of concerned Chief Engineers, it is necessary that a periodical review in this matter is taken up at Chief Engineer level in respect of all Divisions under him. Accordingly, it is requested that all Chief Engineers in the field formations of CWC to pass suitable instructions to concerned officers to put all out efforts to expedite the matter. In this connection, fortnightly meeting under the Chairmanship of Chief Engineers may be held to discuss the pending pension cases with the division offices to streamline the process of timely issuance of e-PPOs to the retirees. Fortnightly report on status of pending pension cases (CE Office wise) may also please be furnished to this office in the prescribed proforma for apprising the status to DoWR, RD&GR/DoP&PW.

As of end November 2022, 2922 Pensioner Grievance cases and 958 PPO's are pending in Ministries/ Departments.

2. May I request you to kindly advise the concerned Nodal Officers to ensure timely redressal of pending pensioners' grievances and cases where PPO's have not been issued.

The Centralized Pension Grievance Redress and Monitoring System (CPENGRAMS) is an online web-enabled grievance redressal module of the Department of Pension & Pensioners' Welfare on which Central Government Pensioner can file their grievances. In addition, grievances are also received in this Department through post, through a dedicated (toll free) Call Centre (1800-11-1960), PMO, DARPG & CPENGRAMS. Monitoring of Pension related grievances is done by the Department as part of its mandate for promoting Pensioners' Welfare.

The Pension processing and sanction of employees is done by line Ministries and therefore all grievances pertaining to a Pensioner are to be addressed by the concerned Ministries themselves. Grievances received by the Department are all electronically processed on CPENGRAMS and forwarded to the Ministries with an outer timeline of 30 days vide DARPG OM No.S-15/21/2021-O/o DS(PG)-DARPG (7085) Dated- 27.07.2022

The Monthly progress report seeks to sensitize Ministries/Departments with respect of Family Pension/Pension grievances and also to ensure that current Pension cases are not delayed & Pension Sanctions are timely issued.







The 110th report (Rajya Sabha Secretariat) of Department Related Parliamentary Standing Committee (DRPSC) on Personnel, Public Grievances, Law and Justice, on "Pensioner's Grievances - Impact of Pension Adalats and Centralized Pensioner Grievance Redressal and Monitoring System (CPENGRAMS) has noted with concern that, on an average, 20% of grievances are not being disposed of within the stipulated time limit of 45 days in case of pensioners and 30 days in case of family pensioners and super senior pensioners (80 years and above). The Committee has recommended that all the Ministries/Departments of Central Government should *identify core grievance-prone areas and streamline their systems accordingly and to resolve the grievances within the prescribed time limit.*

- 2. In view of the above, all Ministries/Departments are requested to take suitable action by identifying core grievance-prone areas leading to delays in sanction of pension/ disposal of grievances in their Ministries/Departments (including all subordinate/attached/autonomous bodies) and streamline their systems accordingly. It shall be the responsibility of each Ministry/Department to coordinate with their Attached/Subordinate/Autonomous bodies for disposal of grievances within the stipulated time frame of 45 days in case of pensioners and 30 days in case of family pensioners and super senior pensioners (80 years and above). A detailed action taken report be sent on every quarter starting from 2nd quarter of 2022 (i.e. 1st July/1st October/1st January/1st April) as per Proforma annexed to DoPPW regularly.
- 3. The Ministries/Departments are further advised to ensure accountability of Government Officials dealing with pensioners' grievances and to take administrative action against officials habitually responsible for delayed action or summary disposal of grievances without qualitative action as recommended by the DRPSC in its 113th Report. A Quarterly report in this regard may also be furnished to this Department in Table C of the Annexure attached.





Recommendation/Observation

3.13 The Committee observes that as per last five years data provided by the Department on satisfaction ratings, about 40% of complainants have rated their grievance redressal as poor. Such ratings reflect poorly on the overall grievance handling by different organizations. Further, about twelve Ministries/Departments in the year 2021 and twenty two Ministries/Departments in the year 2020 have failed to resolve more than 30% of pensioners' grievances pertaining to them within the stipulated time. This shows apathy of those organizations towards handling of pensioners' grievances and the Committee feels dismayed over indifference shown by government officials to the grievances of their retired colleagues. (3.40)

3.14 The Committee accordingly recommends the DPPW to develop a mechanism/guidelines/policy to ensure accountability of the government officials dealing with the pensioners' grievances and suggest action against the erring officials. The appellate authority should be empowered to award monetary penalties and sanction disciplinary action against those officials who are habitually responsible for delayed action or summary disposal of grievances without any qualitative action. (3.41)

Action Taken

3.15 DoPPW has issued advisory to all Ministries/Departments vide OM dated 04.04.2022 (copy enclosed).

Further observation

3.16 The Committee notes the reply of the Department. The Committee recommends the Department that particular Ministries/Departments which are failing to resolve more than 30% of pensioners grievances should be issued separate advisory to furnish reasons for not resolving a high percentage of grievances within the stipulated time.
