To give a chance to the outstation members of CWPESA to participate in the election process, it has been decided to conduct **elections for the posts of 1 Secretary (CWES) and 3 Executive Members (CWES)** through the online mode. CWES Members are requested to participate by sending their vote to **ro.cwpesa@gmail.com** from their personal NIC mail id (selecting up to a maximum of 1 out of 2 candidates for Secretary (CWES) and 3 out of 6 candidates for Executive Member (CWES) & also mentioning Name and Designation of the candidates chosen, clearly in the mail body along with their Name, Designation and Mobile Number. All votes will carry equal weightage irrespective of the sequencing of the candidates' names. The votes will be treated as invalid if the participant votes 2 out of 2 nominations in the case of Secretary and more than 3 out of 6 nominations in the case of Executive Members. Email from official NIC ID of Directorate/Units/Office will not be valid. The **voting process will commence at 10 AM on 27.01.2023 and end at 5 PM on 27.01.2023**. Results will be declared on 30.01.2023 at 5 PM. Any representation for re-counting has to be made by 5 PM on 31.01.2023. To maintain the secrecy of the election process, the email votes cast by the members will be deleted from inbox of ro.cwpesa@gmail.com at 5 PM on 01.02.2023.
