Connecting Panchna dam is part of a larger project of Govt. of Rajasthan named Eastern Rajasthan Canal Project. The project envisages intra-basin transfer of water within the Chambal Basin by utilising surplus monsoon water available in Kalisindh, Parvati, Mej and Chakan sub-basins and diverting it into water deficit sub-basins of Banas, Gambhiri, Banganga and Parbati. The salient features of the project and its status of appraisal is enclosed as Annex-I .
