In terms of provisions contained in Rule 39(2) of CCS(Leave) Rules, read with Ministry of Personnel, Public Grievances & Pension OM No.14028/3/2008-Estt(L) dated 25.09.2008, sanction of the competent authority is hereby accorded to the payment of Rs.13,09,759/-(Rupees Thirteen lakh nine seven hundred fifty nine only) to Shri Pappuri Siva Prasad , Assistant Executive Engineer, CWC who retired from Govt. Service on 31-03-2023 on attaining the age of superannuation, towards the amount of leave encashment equivalent to 297 days EL+ 03 days HPL as per rules.
