ORDER

In partial modification of this Commission's order of even number dated 2<sup>nd</sup> February, 2023, in terms of provisions contained in Rule 39(2) of CCS(Leave) Rules, read with Ministry of Personnel, Public Grievances & Pension OM No.14028/3/2008-Estt(L) dated 25.09.2008, sanction of the competent authority is hereby accorded to the payment of Rs.12,79,260/- (Rupees Twelve lakh seventy nine thousand two hundred and sixty only) to Shri D.Marappa, Assistant Director, CWC who retired from Govt. Service on 31-12-2022 on attaining the age of superannuation, towards the amount of leave encashment equivalent to 300 days EL which he was having at his credit.

At the time of retirement, his leave account has 300+7 days earned leaves and 404 days of HPL. His leave account has now been closed and no leave is to be debited from his account and not leave is to be sanctioned.
