Sub: Grant of one-time relaxation in calculating qualifying service of Seasonal Khalasi, CWC – regarding.

Sir,

I am directed to refer to DoWR, RD & GR's letter No.A-50013/331(part 2/2021-E.I dated 27.04.2023 on the subject mentioned above.The DoWR is considering the proposal for granting of onetime relation in calculating qualifying service of 108 W/c Khalasis who retired prior to 2016 and had been denied pension for having not completed requisite qualifying service of 10 years but would become eligible for pension if proposed relaxation in provisions contained in para 6(iv) of the 1997 Temporary Status Scheme is granted i.e. counting 50% of service rendered (prior to temporary status) and 100% after gr ant of temporary status.

The department has further requested to furnish the details of W/c khalasis apart from the 108 cases already sent to them, who may retire without completion of 10 years of service in normal course, but would complete 10 years if 50% of service rendered (prior to temporary status) and 100% after grant of temporary status is counted by relaxation along with the financial implication.

It is therefore requested to furnish the details of such W/c employees who retired in 2016 and thereafter, in the enclosed prescribed proforma.
