It has been indicated by Secretary, CWC that NWA, Pune does not keep provisions for reimbursement of TA/DA from their own funds to the CWC officers (either from Headquarter or field) who are being called to NWA, Pune as faculty, which needs to lot of difficulties as provisions of funds under Non Plan (DTE) are not adequate resulting into non-payment of such bills to such officers for long time.

In view of the above, it is requested that NWA, Pune, may keep the provision in their estimate for reimbursing TA/DA to the faculty members being called by them from CWC (headquarter/field) as there are sufficient provision of the funds in NWA, Pune under plan scheme

Delegation of power in respect of "Re-imbursement of TA/DA to the visiting Sub: faculty "

NWA's No. E-23012/1/2011-NWA/4420 dated 01.11.2012. Ref:

Sir,

Vide the above reference, CE, NWA, CWC, Pune has requested for modification of delegation of power to him in respect of re-imbursement of TA/DA to the visiting faculty. The proposal has been examined for different category of faculty and the decision of the competent authority is indicated as below:-

Sl. No	Category of faculty	Decision of the competent authority
a.	Serving officers of CWC/MoWR and entitled for air travel	There is an established procedure formulated by Training Directorate regarding finalization of faculty from CWC in a training programme organized by NWA. The Faculty so finalized gets the tour programme approved (as per his entitlement) by competent authority in CWC for visiting NWA, Pune to deliver lecture. In such cases, there may not be requirement of any delegation of power to CE, NWA as the tour programme of CWC faculty is approved by competent authority and NWA is to only reimburse the TA (with air fare)/DA. Similarly, there may not be any issue on reimbursement of TA (with air fare) / DA for faculty delivering lecture in training programmes organized by NWA to officers from MoWR.
b.	Serving officers of other Central Government offices and entitled for air travel	In this case also, there may not be any requirement of delegation of power to CE, NWA as the process of tour programme approvals as per their entitlement according to Gol rules and reimbursement of TA/DA to officer on tour is standard in

c.	Serving officers of state Government who are entitled for air travel according to relevant rules applicable to them	1. As per rule position under SR 190 of the Traveling Allowance Rules (FRSR Part-II), these category of employees would fall under the "Non-official" category and their cases of reimbursement of TA/DA will be regulated by SR 190 and GoI orders there under [Para A (A) & (B) of APPENDIX 2 of FRSR Part-II (Travelling Allowances Rule) and as amended from time to time.  2. Further, by GoI orders under the SR, Such officers are considered as non officials and are entitled to travel on Government duty by first class AC- 2 tier by train including Rajdhani Express trains.  3. As per para (A) (1) (i) and (A) (1) (iv) of the GoI orders mentioned in appendix-2 of the FRSR Part-II (Travelling Allowances Rules), such officials are permitted to travel by air in connection with Government work with the personal approval of the Secretary of the Ministry/Department concerned.	
d.	Retired Central Govt. Servants (including form CWC and MoWR) who before their retirement were entitled to travel by air.		
e	Salaried employees of Universities, institutions, Autonomous bodies etc. who are entitled to travel by air under the rules applicable to them in their own organizations.		
f f	Private individuals who are reputed experts in their own disciplines.
