Reference is invited to this department's Office Memorandum of even number dated 30th September, 2014 on the above subject.

- It had been conveyed that for grant of family pension under the CCS (Pension) Rules, 1972, the authority competent to issue disability certificate would be as specified in the guidelines issued by the M/o Health & Family Welfare Notification No.S.13020/1/2010, dated 18.6.2010, in pursuance of the Persons with Disabilities (Equal Opportunities, Protection of Right and Full Participation) Rules, 1996. It had also been conveyed that for the past cases, the disability certificate issued either in pursuance of the guidelines, dated 18.06.2010 or in pursuance of rule 54 (6) of the CCS (Pension) Rules, 1972 shall be acceptable.
- As per Section 2(p) of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, "medical authority" means any hospital or institution specified for the purposes of this Act by notification by the appropriate Government. In pursuance of this, State Governments/UT administrations are required to notify the medical authorities to issue disability certificate.
- In addition to the authorities indicated in para 2 above, for grant of family pension under the CCS (Pension) Rules, 1972, including pas' cases, the authority competent to issue disability certificate would be any hospital or institution specified as a Medical Authority for the purposes of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act by notification by the Central Government or a State Government or a Union Territory Administration.

ORDER

- 1. This Bench is constituted only for the purpose of deciding the applications filed by the Union of India seeking certain clarification/modification in the orders passed by a Bench of three learned Judges of this Court dated 11.08.2015.
- 2. We have heard Shri Mukul Rohtagi, learned Attorney General for India, Shri Shyam Divan, Shri Soli Sorabjee and Shri Gopal Subramanium, learned senior counsels in extenso.
- 3. After hearing the learned Attorney General for India and other learned senior counsels, we are of the view that in paragraph 3 of the Order dated 11.08.2015, if we add, apart from the other two Schemes, namely, P.D.S. Scheme and the L.P.G. Distribution Scheme, the Schemes like The Mahatma Gandhi National Rural Employement Guarantee Scheme

(MGNREGS), National Social Assistance Programme (Old Age Pensions, Widow Pensions, Disability Pensions)

Prime Minister's Jan Dhan Yojana (PMJDY) and Employees' Providend Fund Organisation (EPFO) for the present, it would not dilute earlier order passed by this Court. Therefore, we now include the aforesaid Schemes apart from the other two Schemes that this Court has permitted in its earlier order dated 11.08.2015.

- 4. We impress upon the Union of India that it shall strictly follow all the earlier orders passed by this Court commencing from 23.09.2013.
- 5. We will also make it clear that the Aadhaar card Scheme is purely voluntary and it cannot be made mandatory till the matter is finally decided by this Court one way or the other.
- 6. All the applications for intervention and impleadment be heard along with the respective main matters.
- 7. Application(s) for modification/ clarification filed by Union of India/UIDAI is/are disposed of.

8. Since there is some urgency in the matter, we request the learned Chief Justice of India to constitute a Bench for final hearing of these matters at the earliest.

Sub: Guidance on the interim orders of the Hon'ble Supreme Court dated 11-08-2015 and 15.10.2015 in W.P. 494 of 2012 and other related matters.

and 15/10/2015 in W.P. 494 of 2012. UIDAI had sought the advice and opinion of the Attorney General (AG) on the usage of Aadhaar by Central/State Governments. The advice/ clarification received from Attorney General is as under:-

Query

Whether in light of the above interim orders, a resident can use his own Aadhaar involuntarily for the purpose for the purpose of his identification and authentication and if so, whether the authorities can accept the said Aadhaar as the resident's proof of identity. For example, if a person uses his Aadhaar card as proof of identity in an airport or to authenticate his identity as part of a government application, can the airport authorities/relevant government authorities accept Aadhaar as the person's proof of identity or ask him to produce some other ID.

Response of AG

Yes, Voluntary use for purposes of identification by an Aadhar cardholder, say at the airport, is valid and it not necessary to ask for production of some other ID.

Query

b) Whether, in light of the fact that the Hon'ble Supreme Court has allowed use of Aadhaar in the Prime Minister's Jan Dhan Yojna (PMJDY) Scheme, an umbrella scheme, which prescribes for channelling all Government benefits through beneficiaries' Jan Dhan Accounts, can the Government implement Direct Benefit Transfer schemes of Government of India if they are channelled through PMJDY accounts.

Response of AG

Channelizing Govt. benefits i.e. DBT Schemes through PMJDY would be in line with the order of the Supreme Court dt. 15.10.2015.

Query

c) For implementation of the welfare programmes, various government agencies and departments have requested UIDAI for biometric information of the individuals who had given their consent for sharing their data at the time of Aadhaar enrolment or subsequently. In light of the interim orders stated above, whether biometrics of such individuals can be shared with the requesting entities.

Response of AG

No. Sharing of biometric data is prohibited.

Query

d) Various government agencies/departments have requested for access to the Aadhaar database to locate the details of the person whose Aadhaar number is not known by matching the demographic details. In light of the above-mentioned interim orders, whether enabling access to the Aadhaar database, in such cases, would be permissible.

Response of AG

No. There is a complete prohibition.

e) Whether, Government departments and agencies can continue seeding Aadhaar on voluntary basis into their beneficiary database.

Response of AG



Subject: Posting of Government employees who have differently abled dependents- reg.

The undersigned is directed to refer to this Department's OM of even number dated o6.06.2014 and 17.11.2014 exempting a Government employee, who is also a care giver of disabled child, from the routine exercise of transfer/rotational transfer subject to the administrative constraints. The word 'disabled' includes (i) blindness or low vision (ii) hearing impairment (iii) locomotor disability or cerebral palsy (iv) leprosy cured (v) mental retardation (vi) mental illness (vii) multiple disabilities and (viii) autism.

- 2. The matter regarding the scope of 'disabled' has been examined in consultation with the Department of Empowerment of Persons with Disabilities. Considering the fact that the child suffering from "Thalassemia" and "Haemophilia" requires constant caregiver support and it would be imperative for the Government employees to take care of their child suffering from "Thalassemia" and "Haemophilia" on continuous basis, it has been decided to include "Thalassemia" and "Haemophilia" in the term of 'disabled' defined in Para 3 of the above mentioned OM dated 06.06.2014.
- 3. The term 'disabled' as defined herein and in OM dated 06.06.2014 and 17.11.2014 is applicable only as grounds for seeking exemption from routine transfer/rotational transfer of a Government employee who have disabled child.
- 4. All the Ministries/Departments are requested to bring these instructions to the notice of all concerned under their control.

Sub: Engagement of Consultants by Ministries/Departments India from bilateral partners and multilateral organisations – Guidelines.

An Inter-Ministerial Committee was set up under the chairmanship of Cabinet Secretary to revisit the matter of engagement of Consultants/Advisors from bilateral partners/multilateral organisations by various Ministries/Departments of the Government of India (GoI). Foreign Secretary and Secretary, Department of Economic Affairs were the other members of this Committee. The Committee obtained information about engagement of Consultants from all Ministries/Departments of GoI and reviewed the present method of engagement of Consultants, including the level of decision making, time frame for engagement and need/justification for external support.

- 2. After analysis of the information received, it has been decided to constitute a Screening Committee comprising Cabinet Secretary, Secretary—Department of Economic Affairs and Secretary of the Ministry/Department concerned to screen and approve all future proposals of engagement of Consultants by the Ministries/Departments directly or through Inlateral/multilateral agencies.
- 3. All contracts of existing Consultants whose tenure is coming to an end by or before 31.12.2015 may be terminated at the end of their consultancy tenure. No renewal beyond 31.12.2015 shall be granted to the exiting Consultants by the Ministry/Department unless approved by the Screening Committee.
- 4. As regards Consultants whose contract tenure is beyond 31.12.2015, their continuation has to be brought before the Screening Committee within a month's time with justifiable reasons for taking a decision on their continuance or otherwise.
- 5. Any proposal to engage new Consultants has to be placed before the Screening Committee mentioned above.
- The following guidelines are prescribed for all Ministries/Departments for processing any proposal for extension/engagement of Consultants before bringing the matter to the Screening Committee:
- i) Consultants should not be engaged for policy formulation. If assistance from Consultants is considered necessary, their role should be limited to presentation and analysis of possible options with supporting data and best practices etc.
- ii) The decision to engage Consultants from bilateral partners/multilateral agencies has to be approved by the Minister In-charge of the concerned Ministry/Department before the proposal is referred to the Screening Committee.

- Terms of Reference and procedure for the recruitment process should be transparent, robust and devoid of any ambiguity.
- iv) Candidates applying for the post will have to submit at least two references from referees of repute.
- v) In case of foreign nationals being engaged as Consultants, necessary security clearance from MHA has to be obtained.
- vi) Consultancy fee, salary, allowances etc. proposed to be paid to the Consultant have to be indicated upfront when the proposal is being placed before the Screening Committee. Any further enhancement has to be with the approval of the Screening Committee. In no case, the Ministry should be unaware of the consultancy fee/ salary and emoluments etc. being paid to the Consultant by the bilateral/multilateral agency.
- vii) Consultants will report only to the Ministry.
- viii) Consultants can be engaged for a tenure of one year at a time. Any extension beyond one year has to be approved by the Screening Committee afresh. An evaluation of the Consultant's performance has to be placed before the Screening Committee by the Ministry.
- ix) Maximum tenure of any Consultant in GoI for a particular assignment cannot exceed three years in any case.
- x) There will be a break (cooling off period) of one year for a Consultant joining another Ministry/ Department after having worked in any Gol Ministry/ Department/State Government as a Consultant for a tenure.
- xi) The Consultant has to sign a confidentiality clause with the Gol. Ethics and Integrity clause is also to be put in place in the contract.
- xii) Consultants shall not share data/information with the bilateral agency/multilateral agency or any person/institution outside the Government without the specific approval of the Secretary of the Ministry/Department concerned. Prior approval of the Ministry may also be taken before publishing any article based on the data, inputs and information obtained as part of the Consultant's work. The Ministries will process such requests within a period of 30 days.
- xiii) The arrangement to engage Consultants should not become permanent. They should be engaged for limited period and for specific purpose only.

7. The above may be noted for strict compliance by all concerned with immediate effect.

OFFICE MEMORANDUM

Subject: Admissibility of Travelling Allowance (TA) and other expenditure incurred while on training by the Government Servants on probation.

Institute of Secretariat Training and Management (ISTM) is conducting Foundation Training Course of newly recruited Assistant Section Officers (DR) and Stenographers (DR). ISTM has received number of references from various Ministries and Departments, requesting for clarification, whether the expenditure incurred by trainee Assistants, now re-designated as Assistant Section Officers, for their boarding, lodging etc. while undergoing Foundation Training, under the aegis of ISTM can be reimbursed to them. Representations have also been received from Assistant Section Officers, through their administrative Ministries in this regard.

- The matter has been examined in consultation with the IFD(MHA) with reference to the Supplementary Rules 164 and instructions issued by the Government from time to time under the aforesaid Rules, which govern claims of Travelling Allowances while on training by probationers. The rule position is clarified as under:-
 - (i) No Travelling Allowance may be allowed for the onward journey for joining the training institute:
 - No Travelling Allowance may be allowed to the probationers while they are taken for (ii) outstation for training activity;
 - (iii) Probationers have to pay boarding /lodging /transport charges, if any, from their pocket.
 - (iv) No daily allowance may be admissible.
 - (v) One side TA may be allowed to the participants while reporting for duty in the allocated Ministry/Department on completion of the Training Programme from an outstation Institute, which are located at Hyderabad, Kolkata, Chandigarh, Shimla and Jaipur, where such training is being conducted by ISTM at present, or any other State Training Institute. which may be identified later, outside NCR.

All Ministries/Departments of Government of India are, therefore, advised to decide the claims made by Assistant Section Offices in respect of reimbursement of expenditure by them for boarding/lodging and other transport charges during the period of their Foundation Training conducted by ISTM, in accordance with the provisions contained at para (2) of this O.M. In case, any reimbursement has already been made, the same may be recovered immediately.
