## OFFICE MEMORANDUM

Subject: Adherence to time schedule for submission of pension cases by Departments and authorization/release of pension – reg.

Timely authorization and release of pensionary benefits to the Government servants is a fundamental requirement. Any delay in this regard is a matter of great concern. Ministry of Personnel, Public Grievances and Pension (PPG & P) has time and again issued directions for timely release of pensionary benefits to Government servants (retiring from Government Service). Rule 56 to 63 of CCS (Pension) Rules 1972 stipulate time schedule for processing the pension papers at different levels in the Departments and Pay & Accounts Offices.

It has been observed that time schedule prescribed in the Rules is not being followed by various Organizations/ departments under this Ministry. Non-adherence to time schedule leads to delay in authorizing the pensionary benefits which tantamount to a punishment for no fault of retirees.

The Secretary, MoWR, RD & GR has taken a serious note on this issue. Therefore, all Heads of the Organizations/ Departments of this Ministry are required to ensure that time schedule prescribed for submission of Pension papers to PAOs and release of pensionary benefits are strictly adhered-to by all concerned in their departments.

This has been issued under the directions of Secretary(WR).

Refer to our letter No. No WR/PAO/CWC/PN/14-15/2966 dated 15-09-2014 requested that the instructions may be issued to all the Executive Engineers of CWC to send the pension case of officers/officials who are going to be retired six months before the date of retirement so that process of the pension case along with all pensionary benefits may be settled well in time. Also requested to furnish the consolidated list of head quarters as well as all the staff of field offices of CWC.

But it has been seen that even now the pension cases of government servants are not being forwarded by the concerned Offices/DDOs of CWC to PAO, CWC before six months from their retirement. The pension cases are forwarded by the concerned offices at last moment and sometimes after the retirement of the government servant.
