Subject: Confirmation/clearance of the probation period of the officials in the grade of Junior Engineer (Civil & Mechanical)-regarding.

Ref: CWC's OM A-31015/2/2023-ESTT-VI dated 15-05-2023 & subsequent reminders dated 04-07-2023 and 08-08-2023.

I am directed to refer to this office earlier communications vide which the concerned Controlling Officers were requested to provide required inputs (Assessment Reports / Vigilance Clearance/ ITP Certificate) for processing the proposal for confirmation/clearance of the probation period of Junior Engineer (Civil & Mechanical) and to state that despite reminders, the requisite information is still awaited.

- 2. It is also mentioned that in some cases the vigilance clearance, which was initially provided is going to expire soon. Therefore, fresh vigilance clearance will require in such cases. This has further complicated the situation and delays the process.
- 3. Non-receipt of requisite information has delayed the confirmation of JEs who have already completed 02 years of service. This has been viewed seriously. Controlling officers are hereby informed that they will be solely responsible for any further delay in the confirmation of these officials.

In view of the above and to address the problem, the following actions are urgently required on the part of Controlling Officers:

- 1. <u>Submission of Assessment Reports:</u> Assessment Reports for the first and second year of service for Junior Engineer listed in Annexure to be provided within seven (7) days from the date of this memorandum.
- 2. <u>Fresh Vigilance Clearance:</u> Fresh vigilance clearance to be provided for the Junior Engineers listed in Annexure whose existing vigilance clearance is about to expire.
