(v)	Recurring Grant-in-aid	Approval of Minister (WR,RD&GR) required.	No limit. Subject to limitation of budgetary allocations/ceilings and directions of Ministry of Finance for recurring grants
(vi)	Non-recurring Grant-in-aid [ which is otherwise part of an approved scheme]	Approval of Minister (WR,RD&GR) required.	Rs.2 crore in each case Subject to limitation of budgetary allocations/ceilings and directions of Ministry of Finance
