

I am to refer the letter cited under reference above and submit to state that the project for the captioned subject was accepted in  $136^{\rm th}$  meeting of Advisory Committee – MoWR, RD & GR held on 06.06.2018 with the following conditions.

- (i) The implementation of the Project should be strictly as per the proposal approved by the Advisory Committee in this meeting.
- (ii) All efforts should be made to complete the project within 1½ years instead of 2 years.
- (iii) The acceptance is subject to No Objection from the Government of Andhra Pradesh which needs to be obtained by the Project Authority.
- (iv) The proposal is accepted subject to submission of State Finance Concurrence by the Project Authority.

The first two conditions will be followed during execution of the project. Regarding condition No.(iii) the Water Resources Department, Govt. of Andhra Pradesh issued No Objection Certificate (NOC) for executing the flood protection work along Gowdami-Godavari River and Coringa Tributes on the territorial limit of Puducherry vide Lr. No.95<sup>M</sup> dated 23.01.2021 (copy enclosed).

While processing the file for obtaining State Finance Concurrence (SFC) of Govt. of Puducherry, the Govt. instructed to foreclose the existing contract at the First instance and reassess BCR through third party before issuing State Finance Concurrence.

As per the direction of the Govt. of Puducherry, the existing contract with M/s. GVR Infra Project Ltd, Chennai for the above work has been foreclosed vide Lr. No.F.694/PW/EE/DB/YNM/2021-22/366, dt.27.08.2021 (Copy enclosed).

Regarding, reassessment of BCR, the Hon'ble Minister for Jal Shakti, Govt. of India has also addressed Hon'ble Lt. Governor, Puducherry vide D.O. No.Z-14012/3/2014-FM(Part-8) vol.II/64, dated 27.01.2021 requesting to submit re-assessment of BCR and pre-requisites like SFC, NOC from Andhra Pradesh etc, to accord Investment Clearance.

Accordingly, the Govt. of Puducherry decided to reassess the Benefit Cost Ratio through the Institution viz. Jawaharlal Nehru Technological University (JNTU), Kakinada, Andhra Pradesh vide No.20295/CS/ 2021, dated 21.12.2021 (Copy enclosed) for the said project. The BCR is expected to be completed within a month.
