Subject: Encouraging submission of write-ups on Anubhav Portal by retiring officers - reg.

Kindly refer to this Department's Anubhav Awards Scheme, 2024 (copy enclosed).

- 2. The Anubhav portal [URL: <a href="https://pensionersportal.gov.in">https://pensionersportal.gov.in</a> /Anubhav/] was launched in March 2015 for retiring government officials to leave a record of their experiences while in Govt. service. It is envisaged that this culture of leaving notes by retirees will enable documentation of administrative history of India. Till date, 96 organizations have registered and more than 10000 write ups have been published on Anubhav Portal.
- 3. An Annual Award Scheme to incentivize and encourage retiring employees to submit their experience write-ups was introduced in 2015. Till date, 54 ANUBHAV awards have been conferred with 4 Anubhav Awards and 9 Jury Certificates being conferred on 23.10.2023.
- 4. Under the 2024 scheme, Central government employees can submit their experiences while working with the Government through Anubhav Write-ups from 8 months prior to retirement up to 1 year after retirement. All write-ups submitted from 01.07.2023 up to 31.03.2024 are eligible to be considered for Anubhav Award 2024.
- 5. It is requested that all central government officers working in Ministries/Departments and autonomous/subordinate/attached offices who will be retiring in the next 12 months may be encouraged to submit their Anubhav on the portal in a timely manner in order to be considered for Anubhav Awards, 2024.
