**Course Content**

**Methodology**

The Workshop will be conducted online on the link through participative methods including experience sharing and discussions etc.

**Eligibility**

Group A & B Gazetted Officers in the Ministries/Departments in the Central and State and middle managements in PSUs/Central Autonomous Bodies.

**Course Capacity**

The maximum number of participants that can be admitted to the Course is 40-50

## Nominations for the Course

## Course Fee

A course fee of Rs. 3000/- per participant will be charged in advance in respect of such officers of Public Sector Undertaking/Autonomous Bodies who may be granted admission in the course. Course fee is required to be paid through a Crossed Cheque/Bank Draft in favour of, **PAO (DP&AR), New Delhi** payable at **New Delhi**. The course fee may be sent by speed post in advance after the participation is confirmed and communicated to the participants before the commencement of the course. If the course fee is not paid in advance, applicant will not be admitted to the programme even after the confirmation of the participation.
