CAD&WM works shall be ensured in the entire command area of the ERM project.
		Further, Para 1.3.2 of the aforesaid Guidelines states that "Mere eligibility of a project does not entitle its inclusion under the scheme of National Projects, and the same is also dependent upon approval of Advisory Committee on Irrigation, Flood Control and Multipurpose projects of DoWR, RD&GR as per laid down procedure, investment clearance, availability of funds, Government priorities etc.
