Sub: Large Scale irregularities in Flood Protection Works in Yanam Region of Union Territory  
of Puducherry -reg

Ref: MoWR RD&GR Lr no Z-20011/12/2013-Ganga/4514 dated 12.11.2014

Kindly refer to the letter cited above, where in OM no U-13014/128/2012-CPD dated 13.10.2014 received from Ministry of Home Affairs along with the letter dated 9<sup>th</sup> September 2014 of Commissioner -Cum -Secretary(PWD), Govt of Puducherry on the aforesaid subject was forwarded to CWC for action as appropriate.

In this context it is mentioned that the proposal of the Government of Puducherry seeking Central Assistance under Flood Management Programme for the project "Flood Protection Works in Yanam Region(DPR-Estimated Cost ₹.140.88 crores) was received on 17.02.2009 through MoWR. During the course of examination it was found that the flood damage data for last 10 years required for calculating the Benefit Cost Ratio and to assess the viability of the project was not submitted along with the DPR and hence Govt. of Puducherry was requested to submit the data. The official of Govt. of Puducherry (PWD) collected the details from Revenue authority of Yanam by fax and submitted personally to CWC on 27.11.2009 during their visit. CWC assessed the techno-economic viability of the project on the basis of document submitted by the Govt. of Puducherry officials and found viable.

Later on it was learnt that, the project was temporarily kept on hold due to the CBI enquiry on the allegation that the flood damage data submitted by the Govt. of Puducherry was forged one. The CBI, Chennai has registered the case (PE 03/(A)/2013) and conducted the enquiry and submitted its report to Govt. of Puducherry with the conclusion that the Flood study damage data furnished by the Revenue department Yanam was not correct and forged one. Based on these findings by CBI, the Govt. of Puducherry has already initiated action by suspending two officials of Revenue Department as intimated by the Commissioner -Cum -Secretary(PWD), Govt of Puducherry in his letter dated 9.9.2014.

Since the flood damage data considered for techno-economic viability of the project during the clearance of the scheme found to be forged one, the DPR has to be reexamined again for its techno-economic viability based on the correct and fresh /actual flood damage data. Further it is also learnt that during execution of the scheme the scope & design has been changed. Due to change in the scope of work and in design aspects, CWC has requested

Govt. of Puducherry to submit the revised DPR in November 2011. In response to this and the findings of CBI, the Govt. of Puducherry has submitted the Revised DPR in January 2014 along with the re-assessed flood damage data. The same was examined in CWC and the comments/ observations were sent to Govt. of Puducherry on 10.02.2014 and 22.05.2014. The compliance on these observations is yet to be received.

In the meantime the Engineering Department of Govt. of Puducherry (CE, PWD) sent a letter to CWC on 30.07.2014 for the withdrawal of the revised DPR submitted by Govt. of Puducherry by quoting the meeting held in the chamber of Hon'ble Union Minister of Water Resources on 27.01.2014, Thus the Administrative Department (Commissioner -Cum - Secretary, PWD), Govt. of Puducherry request dated 09.09.2014 addressed to Ministry of Home Affairs, for keeping alive the revised DPR (which is likely to be revised for an amount of ₹ 173.08 Cores due to cost escalation) is contradictory to the Engineering Department's proposal for withdrawal of revised DPR.

The Govt. of Puducherry may intimate their firm views about the revised DPR of this scheme before resuming the work so as to initiate the appropriate action from CWC in this regard.

However the updated status note of the " Flood Protection works at Yanam Region of Union Territory of Puducherry" along with the observations/ Comments of CWC are also enclosed.
