Ministry of Finance, Government of India vide their Office Memorandum dated: 30.09.2016 stated to provide central assistance to Polavaram irrigation Project in the following manner:

"It will provide 100% of the remaining cost of the irrigation component only of the Project for the period starting from 01.04.2014, to the extent of the irrigation component on that date."

Central Assistance is provided on the expenditure made on the Polavaram Irrigation Project as reimbursement.
