

In this regard, the reply to referred questions from Flood Management Organisation (FMO) is as under:

1.	I want to know information about the flood disaster took place in Delhi?	No specific information available .
2.	flood?	Flood Waves was the result of heavy rainfall in the catchment of River Yamuna along with exceptionally high rainfall in the districts of Yamuna Nagar, Karnal, Panipat, Sonipat and Delhi, and other adjoining catchment of River Yamuna. This lead into generation of high run-off which increased the discharge in river Yamuna and raised the level of River Yamuna abruptly.
3.	been taken?	CWC issues flood forecasts as a non-structural measure of flood management, to concerned State Governments with consent from them at identified locations. CWC also issues inflow forecasts to identified reservoirs for proper reservoir regulation. CWC issues flood forecasts as per standard operating procedure.
4.	Are there any serious damages for anything or anyone?	
5.	What are the precautions to be taken to avoid such disasters in near future?	No specific information available.
