	In village Rasulpur Pitonjia under Bagmati Division Sitamarhi, Bihar, the Bagmati river is continuously eroding for the last 2 years due to which the existence of the village is in crisis. In this context I would like to have the following information.	
1.	What measures have been taken by the responsible institutions at local level, district level, state level and central level for prevention of soil erosion and flood in this area? (Office details to be furnished)	There are two Flood Forecasting (Level) sites in Sitamarhi district in Bihar on the river Bagmati namely Dheng Bridge and Runisaidpur. As non-structural measures for flood management, Flood Forecast are being issued for these sites as per SOP.
2.	How much fund was released in this area in the last year to stop soil erosion and what is the ground reality of the work done from the fund?	No specific information is available in Flood Management Organization.
