Chalk out plan on drinking water: CM

Directs officials to utilise water from new reservoirs

Chief Minister A Revanth Reddy on Tuesday asked officials to prepare an action plan to address drinking water shortage in the ensuing summer. In addition to River Krishna and River Godavari, officials were asked to utilise water from the newly constructed reservoirs for drinking water needs and prepare plans accordingly.

This would aid in comfortable supply of drinking water to the surrounding villages from the reservoirs at a low cost, he said.

'The newly constructed Mallanna Sagar, Kondapochamma Sagar and Ranganayaka Sagar reservoirs should be utilised for drinking water requirements," Revanth Reddy said at a meeting with Panchayat Raj and Rural Development Department officials here on Tuesday. Asking for measures to tide over the drinking water crisis in the summer, he said Rs 1 crore should be spent exclusively for drinking water needs from the Rs 10 crore Special Development Fund sanctioned to each Assembly constituency. Water available in all the projects and reservoirs in the State was to be utilised for drinking water needs on priority, he

said, also directing officials to entrust the responsibility of drinking water supply management in every village to sarpanches.

The Mission Bhagiratha wing should be entrusted with the task supplying safe drinking water in the villages, he said. Maintenance of drinking water supply network, taps and pipelines in villages should be entrusted separately to the Sarpanches. Calling for a comprehensive survey to identify villages and habita-

tions that are facing drinking water issues, he said the new proposals should be prepared for sending them to the Centre to seek funds under the Jal Jeevan Mission.

"As the term of sarpanches ends by the end of this month, officials should take up the responsibility of drinking water supply in villages," the Chief Minister directed.

Stating that the government would pay special focus on strengthening the Self Help Groups, the Chief Minister suggested that women SHGs should be given work orders of stitching uniforms for students in government schools, Gurukuls, hostels and police. If required, the women groups should be provided training, he said.

When officials informed that 422 Gram panchayats and 3177 habitations lacked road connectivity, the Chief Minister directed them to lay black top roads in such villages. If required, the employment guarantee scheme funds should be linked to the road development works, he said, asking them to prepare proposals for required funds for allotment in the budget.

Panchayat Raj and Rural Development Minister D Anasuya, Roads and Buildings Minister Komatireddy Venkat Reddy and senior officials were present.

Delhi govt asks for 12 weeks to demarcate Yamuna's floodplain

NEW DELHI: Experts have long held that there is a simple reason why the Delhi government has been unable to protect the Yamuna floodplains — they have never been demarcated and defined.

After the National Green Tribunal (NGT), in October, pushed the administration to do so by setting up a panel for the task, the Delhi government, in a submission to the body on January 29, has sought 12 weeks to complete the virtual demarcation of the floodplains, and a physical demarcation on the

through signage and pillars. Floodplains are a critical ecosystem - they are a natural barrier against floods, serve as an ideal recharge mechanism (for rainwater especially), and provide a home to diverse flora and fauna. But they are usually neglected, and often encroached upon — often with disastrous consequences for not just the river, but also human habitations along its banks.

Floods such as the one last year which saw the Yamuna water level rise to an all-time high of 208.66 metres on July 13, with the river's waters almost reaching the Supreme Court and besieging the Red Fort, can be directly attributed to abuse of

the floodplains, experts say. NGT, in October, took cognizance of a media report and formed a committee headed by the Delhi chief secretary to identify, demarcate and notify the floodplains of the Yamuna as per the River Ganga (Rejuvenation, Protection and Management) Authorities Order, 2016.

It added that the delineation of Yamuna was required to prevent illegal developments in the floodplains.

The committee also com prises a nominee from Delhi Development Authority, the Secretary (Environment); the Secretary (ministry of Jal Shakti); executive director, National Mis-sion for Clean Ganga (NMCG); and commissioner, Municipal Corporation of Delhi (MCD).

"The committee will get the spot inspection done and ensure demarcation of flood plains of



In October, NGT said that delineation of Yamuna was required to prevent illegal developments.

Yamuna in the area concerned and suggest measures to prevent and remove the encroachment and unauthorized constructions falling within the flood plains. NGT said in its order dated October 17, 2023.

In a submission on January 29, the environment department of the Delhi government told the tribunal that it will take two weeks for the remote determination of the floodplain area, fol-lowed by another two weeks to prepare high-resolution images using Geospatial Delhi Limited (GSDL), a company that main-tains and update spatial data through mapping and surveys, and four weeks for on-ground verification of the same area, after which physical demarca-tion on the ground will com-

In its submission, the Delhi government added: "The com-mittee has deliberated at length the timelines required for the exercise and found that the operation needs massive interdepart-mental collaboration, collection of data, ground surveys, verifica-tion and on-ground demarcation to ensure effective implementation of this Tribunal's directions and thus requires more time. It is prayed further a time of 12 weeks may be granted to the concerned agencies to complete the exercise and ensure compli-

The submission added that DDA estimates the so-called Zone O of the Yamuna to be 9,700 hectares with the area occupied by the river itself being around 1,146

Of the balance, land available for development is 3,493 hec-tares (1,647 hectares of this is with DDA); the remaining 5061 hectares is with other depart-ment and agencies, and also home to 94 unauthorised colo-

The Delhi government depart-ment also said that DDA carried out a floodplain area demarcation, based on a 2015 NGT order that sought the demarcation keeping in mind a possible "1-in-25 year flood" (a rare occurrence with a 4% chance of occurring every year).

That exercise (done in association with the Indian Institute of Technology, Delhi), however, has been questioned by the National Mission for Clean Ganga (NMCG), which, in January 2022, directed the demolition of structures in the floodplains noting that the DDA demarcation was "inappropri-

ate" and "not done properly". In the draft master plan for 2041, which is yet to be notified, DDA split this zone into Zone Ol and Zone O2, with regulated development being allowed in

What happens now

To determine the area with other agencies and government departments along the flood-plains, the NGT-appointed committee has directed GSDL to pro-cure high-resolution images of the floodplain area and coordinate with different departments and agencies for the preparation of a detailed map, the submis-

sion stated.
"The committee stressed on the granularity of data required from DDA on this exercise, which included a detailed department-wise/agency-wise break-up of area in terms of ownership and land use. ...Also directed DDA to submit the area which is clearly free from encroachment and encumbr ces and also enquired from DDA about the area under private ownership," the submission added, stating that each government department or agency owning land along the floodplains has to appoint a nodal officer and share information with GSDL within four weeks. Experts said until the demar-

cation is done, unauthorised colonies and structures cannot be removed.
"DDA has said it has done a

1-in-25 year floodplain demarcation in the past, but we don't see any bollards or markings in the Yamuna, barring a few limited places, like Baansera. The O-zone also exists on paper and until there is clear demarcation of floodplain area, how can we stop projects from taking place on floodplain land?" asked Bhim Singh Rawat, a Yamuna activist and member of the South Asia Network on Dams, Rivers and People (SANDRP).

Revanth seeks to aid water supply

DC CORRESPONDENT HYDERABAD, JAN. 30

Chief Minister A. Revanth Reddy instructed officials to prepare an action plan to meet the increased demand for drinking water in the summer, including making village administrations responsible to supply water in their areas. Mission Bhagratha had failed to fulfil its purpose, he said.

Revanth Reddy asked officials to utilise water from the newly constructed reservoirs like Mallannasagar, Kondapochammasagar and Ranganayakasagar apart from the projects on the river

Krishna and Godavari for the purpose.

He explained during a review meeting on panchayat raj and rural development department affairs that it would be easier and less expensive to supply drinking water to the surrounding villages from the reservoirs.

He said that the previous BRS government's claim of the supplying safe drinking water to every household had not helped the state. Due to this, the state could not get funds under the Jal Jeevan Mission from the Centre.

He cautioned officials against projecting the state as being 'rich'— something that the BRS government did—by suppressing facts. People were still facing drinking water problems in tandas, gudems and agency areas. He recalled that in Khanapur village, people had told him of a drinking water shortage.

Mission Bhagiratha has

been asked to take the responsibility of supplying safe drinking water to the villages. The CM said that sarpanchs should be entrusted with ensuring that drinking water supply reaches every hold in the villages. He directed officials to finalise procedures for this. Maintenance of drinking water supply, taps and the pipelines in the villages should be entrusted separately to the sarpanchs.

rately to the sarpanchs. With the tenure of sarpanchs coming to an end at the end of the month, the CM asked the authorities to take the responsibility of drinking water supply in the villages. Engineers were asked advised to visit all villages and prepare a list of habitations without a proper drinking water supply facility. New proposals for funding to accomplish the last mile connectivity will be made and sent to the Centre to seek funds under the Jal Jeevan Mission, Revanth Reddy said.

Revanth Reddy said no one was paying attention to the intra-village works and house-to-house tap water supply under Mission Bhagiratha. The CM directed that a comprehensive survey be conducted to indentify villages and habitations which are short of drinking water. For the summer, he directed officials to use ₹1 crore of the ₹10 crore Special Development Fund given to each Assembly segment for drinking water needs.

On other issues, he said the government would lay special focus on strengthening the self-help groups (SHGs) by providing financial support. The CM suggested that the SHGs be given the work of stitching the uniforms for students of government schools, Gurukuls, hostels and the police.

The groups will be provided the required training. Revanth Reddy directed officials to develop a road network in the villages and connect all habitations after officials informed him that 422 gram panchayats and 3,177 habitations still do and not have road connectivi-ty. He ordered officials to lay black top roads in the villages. The employment guarantee scheme funds will be linked, if neces-sary, for road develop-ment works. Revanth Reddy asked officials to prepare proposals for funds in the new Budget.

Gusty winds & drizzle likely today, says IMD

Minimum temperature may settle around 10 degrees Celsius, says weatherman

ith the weather witnessing fluctuations these days, the national capital is likely to witness moderate to dense fog on Wednesday morning with minimum temperature settling around 10 degrees Celsius, the India Meteorological Department (IMD) said.

The weatherman on Tuesday said that a generally cloudy sky with light rain or thundershowers accompanied with 'Gusty Winds' is likely for Wednesday towards evening.

On Tuesday, the city woke up to shallow fog during the morning hours, while minimum temperature settled at 8.7 degrees Celsius, which was a notch below the season's

The sun, which was there for sometime during the day provided a little comfort,



and the maximum temperature here touched 21.4 degrees Celsius, which was a point below the season's nomal, the weather agency said. Relative humidity during the day pegged between 80 to 100 per cent, as per the weather department.

However, towards the evening the mercury again

witnessed a drop and the calm but cold winds at a speed of around 7.4 km per hour made the people feel the winter chills.

According to the Indian Institute of Tropical Meteorology (IITM), the predominant surface wind is likely to be coming from Southeast directions in Delhi with wind

speed 12-20 kmph, generally cloudy sky and very light rain/drizzle on 01.02.2024.

Meanwhile, the city's average air quality on Tuesday reeled under the 'very poor category, according to the Central Pollution Control Board(CPCB). Air Quality Index (AQI) of the city on Tuesday was 357.

The IITM forecast for the coming days suggest that the AQI may improve due to the change in weather with rainfall on the cards.

SBI to Down-sell ₹11,000-cr Exposure to Ganga Expressway Project

NaBFID, REC, PFC and Union Bank have shown interest in buying the debt from SBI: Sources

Mumbai: More than a year after disbursing loans to Adani Group's Ganga Expressway project, State Bank of India (SBI) is in the process of downselling half of the nearly ₹11,000-crore loan exposure to the longest tolled road-project in the country.

The lender is in talks with financial institutions, such as the National Bank for Financing Infrastructure and Development (NaBFID), Punjab National Bank (PNB) and some power finance companies, to down sell half

"SBI is down-selling Ganga Expressway loans to banks and financial institutions and is in the last leg of the process," a banking industry source told ET. "SBI underwrote the entire amount with a view of down-selling part of it. It is up to the bank's risk management team to decide on how much to keep and how much to down-sell."

It is a standard practice in the infrastructure financing space for est in buying the debt from SBI, inclu-



banks to downsell portions of large loan exposures

At least four lenders have shown inter-

ding National Bank for Financing Infrastructure and Development (NaB-FID), REC, PFC and Union Bank of In-

dia, another banking source said. The loan, which is long term, fits well with the portfolio of NaBFID, an infrastructure-focused financier, as it seeks to sanction up to ₹1 lakh crore by March 2024. So far, it has disbursed ₹21,000 crore of loans, another source said.

SBI refrained from selling down a portion of the loan in the previous year. The bank may decide to proportionately sell down the loan to all lenders based on their sanctions, the source added.

Spokespersons of SBI, NaBFID and REC did not immediately respond to requests for comment, while Union Bank of India could not be immediately reached.

The Ganga expressway in Uttar Pra-desh, which will connect Meerut with Prayagraj, is going to be India's longest expressway implemented on a toll basis. In 2021, Adani had won contracts from the Uttar Pradesh government to build three stretches of the 594-km Ganga Expressway while the fourth section was awarded to IRB Infrastructure. Of its 594-km length, the Adani group is building 464 km from Budaun to Pravagraj, which comprises 80% of the expressway project.

शंखावत ने कहा कि प्रधानमंत्री जी ने पीकेसी-ईआरसीपी के रास्ते को ढूढने में अपने अनुभव से बहुत बड़ी भूमिका का निवंहन किया है। क्योंकि यह अंतरराज्यीय नदी जोड़ने की परियोजना है और केन-बेतवा लिंक प्रोजेक्ट में प्रधानमंत्री जी ने 90% ग्रांट भारत सरकार देगी, इसका मार्ग प्रशस्त किया है। मुझे पूरा भरोसा है कि इस प्रोजेक्ट के लिए भी प्रघानमंत्री जी अनुग्रह करके हमें 90% घनराशि उपलब्ध कराएंगे। इससे राजस्थान और मध्य प्रदेश को सम्मिलित रूप से मात्र ४००० करोड़ रुपए खर्च कर ५००० एमसीएम पानी मिलेगा।
